Ben Babb, City Engineer, spent some time talking to the Board, about the building, of sewers for property in the West Hills district.

At the hour of 1:30 P. M., all members of the Board, except J. M. Sanderson, who was not present, Asa R. Colman, County Weed Supervisor, Deal Six, County Agent, and Ed Johnson, Commissioner-elect, met with T. F. Yost, State Weed Supervisor for a detailed discussion on the bindweed program for the year 1941. Senator Robert C. Rankin, was, also, present.

Asa Colman, gave a report on the bindweed work for 1940 and, also, for 1939 and 1938. Although the bindweed program for 1941 was filled out, same was set aside for the approval of the new Board of Commissioners, who will take office on the 13th day of January, 1941. Both the report, given by Mr. Colman and the outline for 1941, may be found on file in the County Clerk's office.

A beer license was issued to J. C. Calhoun as per the following motion:

## RESOLUTION

WHEREAS, on the 31st day of December, 1940, the same being a regular adjourned meeting of the Board of County Commissioners, the application of J. C. Calhoun for a beer license came on for consideration of said Board, and

WHEREAS, the Board does find that due and legal notice has been given to the Grant Township Board and that ten days have expired from the giving of said notice, and that no written objection has been filed by the Grant Township Board, protesting the granting of a beer license.

NOW, THEREFORE, BE IT RESOLVED that the applicant J. C. Calhoun be granted a license to sell cereal malt beverages for consumption on premises at the place so described in application.

BE IT FURTHER RESOLVED that T. R. Gerhart, County Clerk of Douglas County, be, and he is hereby directed to issue said license.

Although Mr. Moore from the Williams-Roberts Motor Company and Sheriff Charles Banning talked to the Board about the purchase of a new care for the Sheriff's office, no action was taken. The Sheriff said that he wanted to do what was the most economical in the long run. He said it was very important that his office had a good car and that it be in excellent condition; and, although, the present car is in good condition, there is no doubt that this second year of service would mean a considerable amount of repairs for it.

By proper motion, second and vote, the following resolution was passed:

RESOLUTION

WHEREAS, for the month of December, 1940, there are just, and due, claims against the Road Fund totaling \$1142.40 for wages, and salaries, and

WHEREAS, the balance in the "Wages" item of the road fund budget now shows a balance of \$181.85, and

WHEREAS, we are authorized by law to increase a budget item by 25% in case of emergency, and

WHEREAS, it is necessary that the item for "Wages" in the 1940 budget be increased by \$960.55 in order to meet all just and due claims, and

WHEREAS, it has been ascertained that an increase of \$960.55 in the item for "Wages" will not exceed the limit for increase of 25%, nor will our total Road fund expenditures for the year 1940 exceed the Total road fund budget for the year.

NOW THEREFOR, be it resolved by the Board of Douglas County Commissioners that the "Wages" item within the Road fund be increased by \$960.55, and that the County Auditor be authorized and hereby instructed to make the necessary budget change.
