All members of the Board of County Commissioners, namely: L. H. Griffith, Chairman, J. M. Sanderson, and Ed Johnson, Commissioners and T. R. Gerhart, County Clerk, met in regular adjourned session at the hour of 9:30 A. M.

The resignation of John E. Stephens as County Engineer was submitted to the Board. However, no action was taken on same this day.

Mrs. Mildred D. Watson, Welfare Director appeared before the Board, presenting her application for this position, for the ensuing year.

After some consideration, J. M. Sanderson moved that the Board re-appoint Mildred D. Watson as County Welfare Director for the ensuing year at the salary of \$150.00 per month. Ed Johnson seconded the motion. On vote, all Commissioners voted "Aye".

Resolution pertaining to appointment of Mrs. Watson is on file in the office of the County Clerk.

Harold T. Baker, applicant for the position of County Engineer, met as per appointment, for an interview with the Commissioners. Mr. Baker's qualifications and experience were discussed thoroughly. Mr. Baker is now employed at the University, working under C. G. Bayles.

Clyde Hosford, in the interest of Daniel Spencer, appeared to discuss the construction of a sewer in the West Hills District. Mr. Hosford had formerly discussed this matter with the Board on July 3, 1940. Again, considerable details were discussed. The Board expressed its desire to consult the County Attorney on this matter.

E. E. Larson, applicant for the position of County Engineer appeared for a personal interview. Mr. Larson is now an Engineer with the State, but would prefer to secure the job with the county, so he could maintain his home on the property he is purchasing in Douglas County. Some time was spent in discussing his qualifications and experience.

On file in the County Clerk's office are applications for the position of Janitor from the following: Arthur E. Richardson, James Tooley, Harold Wilburn and John Taylor. It was directed that these people be contacted and asked to appear before the Board for an interview.
