At the hour of 9:30 A. M., all members of the Board of County Commissioners, and the County Clerk met in regular adjourned session, in the regular meeting rooms of the Board.

Oscar Miles, who has applied for the position of Superintendent of the County Farm appeared for a short discussion in regard to this position.

Due to the difficulty of getting in and out of his yard, Josse Sutton asked the Board to bring him a load of rock, in order that he may improve this entrance, since the dirt which formerly had filled the ditch, has washed away. Mr. Sutton stated that he would rather have the rock than a culvert. The Board informed him that this rock would be delivered just as quickly as it could be secured from the quarry.

After reviewing all the applications received for the office of the County Engineer of this county, final action was taken as follows:

J. M. Sanderson moved that E. E. Larson be employed as County Engineer of Douglas County for the ensuing year, at a salary of \$180.00 per month, his services to begin February 1, 1941. Louis H. Griffith relinquished the Chair to Ed Johnson, and seconded the motion. On roll call, by Acting Chairman Ed Johnson, all Commissioners voted "Aye". , 1941 .

The Board spent the afternoon session at the Lone Star Lake, and then adjourned to meet Wednesday, January 22, 1941.

Ralph Davis from Eudora, inquired as to the position of County/Superintendent, stating that he is desirous of applying for said position. The Board instructed him to file an application for same.

John Laird, Representative of the K-T Oil Corporation, met with the Board to explain fully the condition of his gasoline bid, submitted on the 18th.

Also, representatives from the Phillips Petroleum Company appeared to clarify their bid.

A Mr. Holton from the Stanolind Pipe Company requested that the county construct a culvert at the entrance to a private road leading to buildings on their property south of Eudora, where it connects with a county road. When the weather permits, the company is planning to rock this private road. The trucks entering the property will not carry over ten tons at any time. Alva Hodges, Road Foreman, was called in, and reported that he could have this culvert in within the very near future. The Board ordered that this culvert be built.

C. B. Hosford and Dan Spencer, again, were in to discuss the sewer matter for the West Hills District. The County Attorney appeared for a short conference.
