Statutes provides that the cost of the main sewer below a fixed point shall be divided between the districts in proportion to the benefits received. Assuming that the cost of the main sewer from the proposed point of connection to its connection with the city sewer was about \$3000, and 77 lots having paid for the sewer, the thirty lots of the Spencers if they had been included would make the average cost per lot for the main approximately \$28.00 for each connection. If the new joint district is formed Mr. Spencer would pay in cash approximately \$840.00, the same to be repaid to those persons who paid for Sewer District No. one in proportion as each paid for the total cost of the joint section in the same manner as though it had all been included in a joint district at the time of building.

Further discussion was postponed until a future date.

Bids for a steel file for use of the Bindweed Supervisor in lieu of the one now in the office of the County Commissioners, were received and opened. Said bids are as follows:

In her application for relief from a tax prievance to the Commission of Revenue and Taxation, Mrs. Peirce asked that the valuation of Lot 96 be reduced to \$100 and the valuation of  $S_2^1$  of Lot 94 be reduced to \$50. After viewing said property, the Board was of the opinion that such reduction was fair, therefore, they recommended in writing to the State Tax Commission that such adjustments be made.
