The Board authorized John Metsker, Superintendent of the County Farm, to install a door bell at the county home.

In special session, all members of the Board of County Commissioners and the County Clerk met in the regular meeting rooms of said Board.

Haines, Commanding Officer of CCC Co. 4719 at Ottawa, Kansas, reported to the Commissioners that he had received instructions to check on fire buckets, fire extinguishers and other items which had been at the CCC camp at Lone Star. The County Clerk agreed to accompany Major Haines to the park for a check on this equipment.

L. H. Menger conferred with the Board on certain matters pertaining to a tower of the Kansas Electric Power Company located, he claims, on his property. However, the company claims this property is situated in the street and not on privately owned property. This property is located in North Lawrence. The Board suggested that Mr. Menger secure more data on this matter and present to the Board so it may confer with the County Attorney.

April 30, 1941.

In regular adjourned session this day, all members of the Board of County Commissioners and the County Clerk met in the regular meeting rooms of said Board.

A request was made by Rev. John E. Bowers on behalf of the Ministerial Alliance that the county allow them the use of one of the buildings at the Lone Star Park, formerly belonging to the CCC Camp. They would appreciate one of the largest buildings. The Commissioners said they would consider his request, and told him that the county would expect the organizations to whom the buildings are allotted, to paint same and keep them up in good repair.

Another request for a building was received from representatives of the Baldwin Lions Club. Representatives appearing were C. B. Butell, V. E. Boardman and Houston Turner. They expect to let the Boy Scouts and other organizations use this as well as their own club. These men felt that they needed a building for that part of the county.

The County Treasurer again made a request that the wages of some of his office employees be increased, namely Mrs. M. E. Eudaly and Mrs. Mary Ellen Simmons. Willfred Eudaly is also asking for an increase. Mr. Flory says he runs his office as economically as he possibly can. The Board did not feel that this was the proper time to increase wages. However, after considering the request of Mr. Flory two Commissioners felt that only one wage increase should be given and this to Mrs. M. E. Eudaly. Whereupon, Ed Johnson moved that Mrs. M. E. Eudaly's wages be increased from 30¢ to 35¢ per hour, effective the first of May. L. H. Griffith seconded the motion. On vote, Commissioners voted as follows:

J. M. Sanderson: No

Motion carried by majority vote.
