W. E. Hoskinson and Ployd Gottstein met with the Commissioners for the purpose of discussing Mr. Gottstein's application for work with the Bindweed Supervisor. Mr. Gottstein's qualifications for the position were thoroughly discussed. Mr. Hoskinson is recommending Mr. Gottstein for the job.

The Board adjourned to meet June 10, 1941.

The Board met as a Board of Equalization for the first day of the final three day session.

Mrs. C. H. Krone, 1134 Emery Rd., representing her mother Jennie Rasymaecker of the same address, appeared to ask for an adjustment on her home, described as N 10' of Lot 13, assessed at \$15.00 and all of Lot 14, assessed at \$115.00 plus \$6300.00 for improvements. The total of said property is now on the assessment rolls in the amount of \$6430.00. Mrs. Krone has been comparing this property with other homes in that vicinity and says that their home is assessed too high in comparison with the others. The Board decided to view this property before reaching a decision.

An appeal was heard from Chester Spray, who asked for a reduction in the assessed valuation of his property located in Eudora Township and legally described as the  $SW_4^1$  of the  $SE_4^1$ , assessed for \$4160.00; the  $MW_4^1$  of  $SE_4^1$ , less  $2^n$  to RR, assessed for \$3900.00; and the  $E_2^1$  of  $SE_4^1$ , assessed for \$7880.00 plus \$1000.00 for buildings; all land in Section 1-13-20. The total of the property as a whole is \$16,940.00. He said he paid about \$82.00 an acre for this land, and believes that the assessed valuation is excessive. The Board agreed to view this property in the very near future.
