## COMMISSIONER'S RECORD N

The Board took favorable action on the road petition presented, and pursuant thereto, passed the following resolution:

## RESOLUTION

WHEREAS, The Board of County Commissioners is duly assembled in a regular meeting of said Commissioners for the purpose of transacting such business as may properly come before said meeting, all of said County Commissioners being present, and

WHEREAS, THERE COMES BEFORE THE Douglas County Board of County Commissioners the matter of the consideration of one Road Petition which was filed on the 10th day of June, 1941; said Petition being signed by S. J. Hunter, as the principal Petitioner and by at least twelve householders of Douglas County residing in the vicinity where said road is to be laid out, and praying for the location of said road as more specifically described in said road Petition, and

WHEREAS, in accordance with the provisions of the Revised Statutes of Kansas for 1935, Section 68-104, S. J. Hunter, Jack Kelsey and Rosabelle Kelsey, his wife, and the Lawrence Country Club, a Corporation, the owners of the land, proposed to be taken in the location of said road as described in said Petition, agreed in writing to the proposed location of said road and waived any right to any damage resulting from the location of said road as set out in said Petition, and

WHEREAS, the Douglas County Board of County Commissioners are satisifed that the location of said road as set out in said Petition is practicable and can be made without unreamonable expense, and

WHEREAS, the Wakarusa Township Board of Trustees has presented to the Board of Douglas County Commissioners their desire and written consent for the opening and location of said road as set out in said Petition, and

WHEREAS, the County Engineer of Douglas County, Kansas, has examined the notes and descriptions of said road as set forth in said Petition, and has found that said description of said road is true and correct, and that the land proposed to be taken for said road belongs to and is the property of S. J. Hunter, Jack Kelsey and Rosabelle Kelsey, his wife, and the Lawrence Country Club, a Corporation, and has so reported his findings to the Douglas County Board of County Commissioners.

NOW THEREFORE, Be it resolved by the Board of Douglas County Commissioners that the following described road to-wit:

Beginning at the Southeast corner of the Southwest  $\frac{1}{4}$  of the Southeast  $\frac{1}{4}$ , Section 26, Township 12 South, Range 19 East; thence North along the East boundary of the East 30 acres of the Southwest  $\frac{1}{4}$  of Southeast  $\frac{1}{4}$ , Section 26, Township 12 South, Range 19 East, eleven hundred eventy-eight and seven tenths (1178.7) feet; thence Southwesterly along a curve of 664.30 foot radius, a distance of 265.00 feet to a point 50 feet West of and 920.2 feet North of the point of beginning; thence South 920.2 feet; thence East 50 feet to the point of beginning

Beginning at a point 1178.7 feet North of the Southwest corner of the Southeast  $\frac{1}{4}$  of the Southeast  $\frac{1}{4}$  of Section 26, Township 12 South, Range 19 East; thence along a curve of 664.3 foot radius, bearing to the East, a distance of 147 feet to a point 85 feet East of the Northwest corner of the Southeast  $\frac{1}{4}$  of Southeast  $\frac{1}{4}$ , Section 26, Township 12 South, Range 19 East; thence East 65 feet; thence Southerly along a curve of 614.3 foot radius, the same being 50 feet Easterly of and concentric with the curve of 664.3 foot radius, a distance of 431. feet to a point 920.2 feet North of the South-west corner of Southeast  $\frac{1}{4}$  of Southeast  $\frac{1}{4}$ , Section 26, Township 12 South, Range 19 East; thence for the point of beginning.

The property described as beginning at a point Twenty (20) chains West of the Southeast corner of Section 26, Township 12, Range 19 East, thence North Ninety (90) feet, thence East to highway, thence in a Southwesterly direction along the West line of said highway to point of beginning,

shall be and the same is hereby declared to be a public township road; that the Board of Douglas County Commissioners find that S. J. Hunter, Jack Kelsey and Rosabelle Kelsey, his wife, and the Lawrence Country Club, a Corporation, are the owners and holders of the land described in said Road Petition, and further find that the provisions of Section 68-104 of the Revised Statutes of Kansas have been complied with, and find that the viewing of such location of such road may be dispensed with, and orders that said road be surveyed, platted and opened, and hereby directs the County Engineer to note such location of said road upon the road records of his office.

BE IT FURTHER RESOLVED, That the width of said road shall be established as 50 feet, symetrical about the centerline described on said Petition.
