Jackson and another representative, met with the Board to discuss their leasing a building at the Lone Star Park. The group present was entirely satisfied with the conditions of the lease and said that they would discuss this among their various organizations before signing same.

Milton Beach, County Attorney and Ernest Klooz, abstracter, met with the Commissioners to discuss the work of said Mr. Klooz in regard to the Judicial Tax Sale. This meeting was primarily for a discussion on the compensation for Mr. Klooz's work on the sale. It was the thought of the Board that some change should be made in the former agreement, since the sale has been postponed due to action of the legislature on the moratorium law. Whereupon, after discussion pro and con, the following motion was made; J. N. Sanderson moved that the contract with Mr. Ernest Klooz dated July 10, 1940, is hereby abrogated by mutual consent, and that in lieu thereof, Mr. Klooz be employed for a period of nine months at \$110.00 a month to complete the tax foreclosure sale for 1936 and all prior years. Ed Johnson seconded the motion. On vote, called by Chairman Griffith, all commissioners voted "Aye".

As per appointment, T. F. Yost, State Weed Supervisor met with the Board, the County Bindweed Supervisor and Accountant Mildred LeSuer for the purpose of discussing the bindweed budget for the ensuing year. This budget was worked out in detail and is on file.
