All members of the Board of County Commissioners and the County Clerk met this 5th day of November in regular adjourned session in the regular meeting rooms of said Board.

Don Hults, Attorney for the Griffith Theatre Corp. again appeared before the Board in the matter of compromising personal property formerly owned by Glen W. Dickinson, on which the 1935 taxes have not been paid. This is now a tax judgment on the books of the Clerk of the District Court. At the time all delinquent taxes against property formerly owned by Dickinson were paid by a compromise tax judgment, this particular item was overlooked and was not included in the compromise. Therefore, Attorney Hults is asking that the Board of County Commissioners enter into such a compromise at this time.

After some consideration, J. M. Sanderson moved that the following resolution be adopted. Ed Johnson seconded the motion. On vote, all Commissioners voted in the affirmative.
