Members of the Wakarusa Township Board and the County Engineer discussed the building of a bridge in Wakarusa Township, with the Board. No definite action taken this day. The Engineer was to check into this matter further.

Deputy Assessor J. M. Clevenger failed to allow constitutional exemption."

No. 246: "CANCEL 1941 personal property tax in the amount of \$6.19, based on a tangible valuation of \$165.00, charged to H. F. DeWolf, 704 Ohio Street, Lawrence, Kansas. City of Lawrence Tax Roll, Page 273, Line 10.

Assessor W. Roy Martin failed to allowed constitutional exemption.

CANCEL 1941 Personal property tax in the amount of \$10.14, based on a tangible valuation of \$270.00, charged to Elizabeth F. Grimes, Haskell Institute. Lawrence City Tax Roll, Page 287, Line 1. ENTER in lieu of same tangible valuation \$70.00 with tax of \$2.63. (Total tax cancelled \$7.51.)

Assessor A. P. Fey failed to allow \$200.00 constitutional exemption."
