## December 31, 1941.

All members of the Board of County Commissioners, namely L. H. Griffith, Chairman, J. M. Sanderson and Ed Johnson, Commissioners, and T. R. Gerhart, County Clerk, met in regular adjourned session this 31st day of December, 1941.

The Board adjourned to the courtroom where a meeting was held by Harold Snider in regard to appointing members of the tire rationing boards for Douglas County. All persons who were appointed by the mayors of the various cities in the county were present as were the mayors and other interested parties.

All instructions and information available were given by Mr. Snider. In addition to the regular members of the tire rationing boards, a local tire administrator should be appointed. J. M. Sanderson, County Commissioner, recommended that Paul Lyons be appointed as local tire administrator.

Flory and E. W. Ousdahl. The local tire rationing administrator appointed was Paul Lyons. Members of the City Board did not take their oaths this day.

The meeting in the courtroom adjourned and the Commissioners once again reconvened in the regular meeting rooms of said Board.

The Board today took action purchasing radioes for the sheriff's car and for those of his deputies. Ed Johnson moved that the county purchase three receiving sets to be installed, one in the Sheriff's car and one in each deputy's car as county property (making a total of three), and the county agrees to finance the purchase of same up to \$300.00.
