Dr. Asher suggested that an advisory board be set up for the county health unit, the members of which will serve in advisory capacity, only, and will have no authority to expend any funds. One of their duties, will be to pass on claims which they will recommend for payment to the proper body of officials. After some discussion, it was thought best to have a seven member board; therefore W. C. Simons moved that this group recommend the formation of an advisory board to consist of two members of the Board of County Commissioners, two members from the City Council, one member from the Douglas County Medical Society, one member from the Board of Education and the seventh member to be selected by the original six members; said Board to be known as the Advisory Board of the Douglas County Health Unit. A. J. Anderson seconded the motion. On roll call by Chairman L. H. Griffith, all members present voted unanimously in favor of said motion.

A motion was made by J. M. Sanderson that Carl B. Butell of Baldwin City be selected to represent the Board of County Commissioners on this Advisory Board. Ed Johnson seconded the motion. On vote, motion carried.

Ed Johnson moved that L. H. Griffith also be selected as the second member of the Advisory Board to represent the Board of County Commissioners. J. M. Sanderson seconded the motion. Motion carried by majority vote.

It was further moved by J. M. Sanderson that all nominations be closed. A second was made by Ed Johnson and by majority vote, motion carried.

This day Mr. Butell was notified of his selection and asked if he would accept this position. Said Mr. Butell accepted.

The Board adjourned to meet Wednesday, April 29, 1942.

The Board of County Commissioners with all members of said Board and the County Clerk present, convened in regular adjourned session this 29th day of April, 1942.

The Board took this day for its monthly inspection of the Douglas County Home and Farm.

Mrs. W. O. Nelson spent some time discussing civilian defense work she has been supervising.

For the purpose of discussing the dispensing of the rationing board in Baldwin, appeared C. B. Butell, Ray Eaton, F. C. Leitnaker and a Mr. Hunt. These men said that they would like to retain the Baldwin Rationing Board as they feel that it is essential to that part of Douglas County. Butell said that Baldwin City could take care of the office expenses for that Board and that he has a vault available for filing of records. It was suggested that this Board could take care of the applications from Baldwin and also from Palmyra Township. Mr. Griffith, Chairman, informed these men that he would write to the State Bationing Administrator regarding setting up a Board for Baldwin City and Palmyra Township.

Refunding Warrant No. 87 was passed by the Board. This was made payable to E. G. Steele in the amount of \$3.71 and refunded on account of over-payment on Redemption No. 7290 paid December 15, 1941.

The following agreement was signed by the three members of the Board:

AGREEMENT

THIS AGREEMENT made this 29th day of April, 1942, by and between Eugene Griffin of Eudora, Douglas County, Kansas, party of the first part, and the Board of County Commissioners of Douglas County, Kansas, Party of the second part.

WITNESSETH, that the said party of the second part, in consideration of the agreements hereinafter included, and agreements of the party of the second part hereinafter included, shall have the exclusive right and privilege of entering property of the party of the first part, to construct a new channel for Little Wakarusa Creek.

IN CONSIDERATION of which the said party of the second part agrees to pay the said party of the first part, for crops destroyed, based on the average acreage production at time of harvest, the price per bushel shall be the local market price where the grain is ordinarily sold.

THE SAID PARTY of the second part further agrees to construct a new channel at a point beginning approximately 635 feet North West in approximate line with the new channel, to a point in the North West corner of the quarter line where the new channel will intersect the old creek; rip rap bank if necessary; waste dirt to be placed in old channel. This channel is to be constructed after present crop is harvested. All trees designated by the party of the first part will be removed by the party of the second part.

IT IS FURTHER AGREED by the party of the second part to remove trees designated by the party of the 1st part, for a distance of approximately 635 feet from center line of road along proposed new channel, and it is further agreed to do what leveling is feasible with a patrol in filling in old channel, and if drainage of field be disturbed, proper drainage into new channel will be established by party of the second part.
