newspaper of general circulation in the county, may allocate all or any part of the residue sales tax for the year of 1942 to the welfare fund for social welfare purposes, and

WHEREAS, it has been determinied by the Board of County Commissioners of Douglas County, Kansas, that because existing conditions necessitate extraordinary demands for welfare purposes upon the county welfare fund, it seems advisable to use for welfare purposes, agreater portion of the available sales tax residue than would accrue to the welfare fund of said county if a distribution thereof be made as provided by law, and

WHEREAS, public notice has been duly given for twenty days prior to the date hereof notifying all political subdivisions, public officers and taxpayers that a public hearing would be held on the matter of allocating the residue sales tax to the welfare fund and that said hearing would be held in the city of Lawrence on the 27th day of June, 1942, as provided in Section 79-3621, supra, and

WHEREAS, when said matter came on for hearing on the date above set forth it was determined by the County Commissioners of Douglas County that it would be necessary to allocate \$27,655.11 of the residue sales tax to the welfare fund for social welfare purposes for 1942.

NOW, THEREFORE, be it resolved by the County Board of Commissioners of Douglas County, Kansas, in meeting duly assembled, that the State Board of Social Welfare is hereby requested to give its consent to the use of \$27, 655.11 of the residue sales tax distributed to Douglas County in 1942, and that this resolution be construed as a formal request to the State Board of Social Welfare to comply with said statute as provided by law.

IT IS FURTHER ORDERED by said Board that the County Director of Social Welfare of Douglas County Kansas, forward to the State Board of Social Welfare a certified copy of this resolution, together with the proof of publication of the notice of public hearing as above set forth.
