COMMISSIONER'S RECORD N

July 8, 1942.

In regular adjourned session this day, there met all members of the Board of County Commissioners and the County Clerk.

Further bills against the county were minutely inspected and by proper motion, second and vote, allowed in amounts as recorded on the Allowance Record.

Henry Asher, Attorney, again appeared before the Board in regard to the matter of correcting an erroneous description of property belonging to Mrs. Jennie Buck. Pursuant thereto, the following resolution was by proper motion, second and vote passed as of this day:

RESOLUTION

WHEREAS, on May 1, 1919, one Rollins F. Buck and Jennie G. Buck his wife, for a valuable consideration made, executed and delivered to the Board of County Commissioners of Douglas County, Kansas, for road purposes a Warranty Deed to the following described real estate:

"Beginning at a point 144 feet West of the East line and 42 feet South of the North line of the Southwest 1/4, Section 18, Township 12, South of Range 18 East, at a point 30 feet South of the center line of the Fort to Fort highway; thence East on a curve parallel and 30 feet from said center line 300 feet; thence North 72 degrees, West 150 feet; thence North 88 degrees West 150 feet to beginning in Douglas County, Kansas,"

which deed was recorded May 2, 1919, in Book 104 at Page 562 in the office of the Register of Deeds of Douglas County, Kansas, and

WHEREAS, the description in said deed is erroneous and the true and correct description of said land actually taken for road purposes is as follows:

"Beginning at a point 1440 feet West of the East line and 42 feet South of the North line of the Southwest 1/4 Section 18, Township 12, South of Range 18 East, at a point 30 feet South of the center line of the Fort to Fort highway; thence East on a curve parallel and 30 feet from said center line 300 feet; thence North 72°, West 150 feet; thence North 88° West 150 feet to beginning in Douglas County, Kansas."

WHEREAS, it is the desire of the owners of said real estate, out of which said tract is carved, and of the Board of County Commissioners to correct and amend said record.

NOW, THEREFORE, be it RESOLVED by the Board of County Commissioners of Douglas County, Kansas, at a regular meeting thereof, that upon the execution and delivery to the Board of County Commissioners of Douglas County, Kansas, of a quit-claim deed from Jennie G. Buck, the present owner of said real estate, to the above described real estate under its correct description, that the Board of County Commissioners of Douglas County, Kansas, cause to be made, executed and delivered to the said Jennie G. Buck a like quit-claim deed, conveying unto her the land described in said erroneous description in the Warranty Deed now of record.

Voted and passed by the Board of County Commissioners of Douglas County, Kansas, this 8th day of July, 1942.
