There assembed in regular adjourned session this day, all members of the Board of County Commissioners and T. R. Cerhart, County Clerk.

The Commissioners entered into a discussion in regard to the work schedule of the men employed by the Engineer's department for work on roads and bridges in the county. As a result of such discussion, it was ordered by the Board that the members of the road and bridge crews be allowed every other Saturday afternoon off; and it was further ordered that all new men being employed on a monthly basis would receive the salary of \$100.00 per month.

Accompanied by the County Engineer, the Board viewed a gravel pit on the Harry Woodring farm in Lecompton Township with the thought of purchasing gravel from Kr. Woodring, same to be used on the county roads in that vicinity.

A tentative offer was submitted to his employee: The county would pay 10% a yard and grade the private road on the Woodring farm from the pit to the township road; OR, the County would pay 5% a yard and grade and gravel said road from the pit to the township road. The county would also agree to take 10,000 or more yards if they are available.

There was presented to the Board a road petition, signed by P. M. Saunders and fourteen others, praying for the vacation of a road described as: Beginning about 80 rods north of the corner of the west line of Section 31, Township 12 S, Range 21 E; thence north to the Kansas River; part of Road No. 39 (Eudora Township).

The petition being in order and the road petitioners' bond being properly signed, the Board unanimously approved and accepted said petition; and by proper motion ordered the road notice published in the official county paper and the date for viewing be set for 2 o'clock p.m., Wednesday, October 21.

No further business appearing, the Board adjourned.
