With all members and the County Clerk present, the Board of County Commissioners met in regular adjourned session this 14th day of October, 1942.

The remainder of claims against the county for materials and supplies were presented by the County Clerk, and after careful scrutiny by the Board, was ardered paid by formal action, as per amounts shown on the Allowance Record.

In a protest over the order of the State Commission of Revenue and Taxation regarding the assessed valuation of property owned by the Victory Life Insurance Company, Topeka, the Board passed the following resolution and ordered that a copy of same be forwarded to the said Commission of Revenue and Taxation.

WHEREAS, an order, issued on the 21st day of July, 1942, and delivered to T. R. Gerhart, County Clerk, on the 22nd day of September, 1942, by the State Commission of Revenue and Taxation in the matter of the appeal of the Victory Life Insurance Company (Appeal No. 59), is deemed by the members of the Board of Commissioners of Douglas County, Kansas, to be erroneous, unfair, unjust, and certainly not in keeping with valuation facts in the case as shown in "Plat A" hereto attached; and

WHEREAS, to obey this order, because of the magnitude of the reduction ordered, would be highly discriminatory as between other property owners in the vicinity and the Victory Life Insurance Company, and might nullify all other equalized values in the City of Lawrence.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Douglas County, Kansas, that the Board vigorously protests this order, and that the State Commission of Revenue and Taxation be requested to reconsider its decision in the light of a fair equalization of this value with surrounding properties.
