Douglas County Republican, Lawrence

No action for the appointment to fill the vacancy was taken this day.

After a discussion with Milton P. Beach, County Attorney, the Board, by proper motion, increased the salary of Alice Patee, Stenographer for said county attorney, from \$60.00 to \$75.00 per month, effective December 1, 1942.

By unanimous approval of all three commissioners, the Board recommended to the Governor of Kansas, the appointment of Rev. Alfred J. Beil as a member of the Selective Service Board No. 1, there being a vacancy caused by the resignation of Neal M. Wherry.

No further business appearing, the Board adjourned to meet Monday, December 7, 1942.

The Board of County Commissioners, with all members and the County Clerk present met in regular adjourned session this 7th day of December, 1942.

Further bills against the county for materials and supplies were closely inspected by all members of the Board, and by unanimous vote were allowed in amounts as recorded on the Allowance Record in the office of the County Clerk.

The following Commissioners Orders were passed by the Board:

No. 265: "On the 1942 Lawrence City Personal Property Tax Rolls, Page 170, Line 13, CANCEL tax in the amount of \$2.68, based on a valuation of \$75.00, charged to Dora Gray, 1015 Woodward, Topeka, Kansas.

Clerical Error."

No. 266: "In the 1942 Land Book #2 Tax Roll, Willow Springs Township, Page 214, Line 26, School District #67, CANCEL Dog tax in the amount of \$2.00, charged to F. C. Flory, Route #6, Lawrence.

Erroneous assessment."

No. 267: "On the 1942 City of Lawrence Tax Roll, Page 77, Line 11, CANCEL tax in the amount of \$95.37, based on a total valuation of \$2670.00, charged to the Socony-Vacuum Company, Kansas City, Mo.

On Page 77, Line 11, Enter the Real Estate tax of \$54.29, based on the valuation of \$1520.00. In the name of the Socony-Vacuum Company, Kansas City, Mo.

Clerical error in making adjustment on improvements on real estate property."

No. 268: "In Land Book 1, Page 81, Line 31, Grant Township, CANCEL Grain tax in the amount of \$1.97 (3940 bu.), charged to Kansas University, Lawrence, Kansas. School District #63.

Erroneous assessment."

No. 269: "In the Outlot 1942 tax record, Eudora City Page 221, Line 15, CANCEL personal property tax in the amount of \$19.32, based on a tangible valuation of \$575.00, charged to H. C. Bohnsack, Eudora, Kansas.

Erroneously placed in City of Eudora; should be in Eudora Township."

The resignation of Melba J. Reetz, Stenographer in the Farm Security's office, was received and accepted by the Board.

There again appeared Emil Heck, Treasurer of Grant Township, to discuss the matter of appointing a Trustee for said township due to the vacancy left by Chas. H. Wood.

After a short discussion, J. M. Sanderson moved that W. H. Weeks, Route #3, Lawrence, be appointed as Trustee of Grant Township, to fill the vacancy left by the resignation of Chas. H. Wood. Ed Johnson seconded the motion. On vote, motion carried by affirmative vote.

With the County Engineer present, there was a discussion on the maintenance of a certain strip of road in Grant Township. Mr. Heck said that the township would maintain the one mile of the Midland Road, at the cost of \$1.00 per trip per said mile. He also stated that the township would agree to shovel the snow from old Highway #40, for a strip running north for one mile; also at the cost of \$1.00 per trip. Said township would charge the county for the cost of same as indicated herein.

Both the County Board and the County Engineer approved this plan of maintenance.

No further business appearing, the Board adjourned to meet Friday, December 11, 1942.
