No. 276: "CANCEL personal property tax in the amount of \$8.20, based on an intangible valuation of \$1640.00, charged to Magdalene Frances Lohman, Executrix, 512 Indiana Street, Lawrence, Kansas. City of Lawrence 1942 Tax Roll, Page 309, Line 32. Erroneous assessment of Building and Loan stock."

No. 277: "CANCEL personal property tax in the amount of \$3.57, based on a tangible valuation of \$100.00, charged to Mrs. Jessie Messenheimer, 434 Locust, Lawrence, Kansas. City of Lawrence 1942 Tax Roll, Page 312, Line 30.

(Drainage tax will remain on the rolls in the amount of 14¢ as shown on Line 30.)

Assessor failed to give constitutional exemption."

No. 278: "CANCEL personal property tax in the amount of \$7.32, based on a tangible valuation of \$205.00; and cancel p. p. tax in the amount of 25¢, based on an intangible valuation of \$50.00, also cancel \$1.00 Dog Tax, making a total tax cancellation of \$8.57, charged to Vincent P. Harris, 2113 New Hampshire, Lawrence, Kansas. City of Lawrence 1942 Tax Roll, Page 290, Line 29.

Did not reside in Kansas on March 1st. Has receipt showing 1942 taxes paid in Missouri."

The Board spent the rest of the day in the Welfare Department.

On this 23rd day of December, 1942, all members of the Board of County Commissioners and the County Clerk met in regular adjourned session in the regular meeting rooms of the Board.

The following Commissioners orders were passed by the Board:

No. 279: "CANCEL personal property tax in the amount of \$2.14, based on a tangible valuation of \$60.00, charged to T. G. McLaughlin, 643, Tenn., Lawrence, Kansas. City of Lawrence Tax Record, 1942, Page 317, Line 38. Erroneously assessed twice."

No. 280 "CANCEL personal property tax in the amount of \$12.68, based on a tangible valuation of \$355.00; AND, CANCEL personal property tax in the amount of 90¢, based on an Intangible valuation of \$180.00, leaving on the tax rolls a tax of \$1.00, based on an Intangible valuation of \$200.00, charged to M. W. Moorhead, 1045 Kentucky Street, Lawrence, Kansas. City of Lawrence 1942 Tax Rolls, Page 315, Line 11. Erroneously assessed; tax paid in Denver, Colorado."

No. 281: "CANCEL personal property tax in the amount of \$1.43, based on a tangible valuation of \$40.00; AND, CANCEL personal property tax in the amount of 95¢, based on an intangible valuation of \$190.00, leaving on the tax rolls p. p. tax of 30¢, based on an intangible valuation of \$60.00, charged to N. T. Klingensmith, 1126 Tennessee Street, Lawrence, Kansas. City of Lawrence 1942 Tax Roll, Page 304, Line 3. Erroneous assessment as Mr. Klingensmith paid this tax in Salt Lake County, Utah."

No. 282: "In the City of Lawrence 1942 Tax Record, Page 353, Line 33, CANCEL an Intangible tax in the amount of \$6.00, and Intangible valuation of \$1200.00, charged to Geo. R. Woodward, 231 Perry, Lawrence, Kansas.

In lieu of the above, CHARGE an Intangible tax of \$6.00, based on an Intangible valuation of \$1200.00 to Mrs. Mary Woodward, 1025 Tenn. Street, Lawrence, Kansas. City of Lawrence 1942 Tax Roll. Taxes erroneously charged against Mr. Woodward because of clerical error."

No. 283: "CANCEL personal property tax in the amount of \$19.11, based on a tangible valuation of \$535.00, charged to J. J. Svoboda, 933 Tenn. Street, Lawrence, Kansas. Lawrence City 1942 Tax Roll, Page 342, Line 33.

Assessment was made and taxes paid thereon in Woodson County on a Lincoln Zephyr Fordor Sedan, 1939. Same was certified by R. G. Rehmer, County Clerk of said county."

No. 284: "CANCEL 1942 Personal Property tax in the amount of \$30.36, based on a tangible valuation of \$850.00, charged to The Crown Cork and Seal Company, on Page 272, Line 23 of the City of Lawrence Tax Roll. Duplicate assessment.

Equipment was assessed equally between the Fritzel Dairy Company and the Lawrence Sanitary Milk and Ice Cream Company."

Chairman Griffith was absent during the afternoon session.

Donald A. Seltsam of the Rhodes-Seltsam Company, Inc., Topeka, and Mildred LeSuer, Accountant, conferred with the Board on the matter of the bond issue for Sewer District No. 3.

Since this bond issue is so small, namely \$1400, Seltsam said that the best rate that could be offered is 2½%, which offer was agreeable with the Board and pursuant thereto, both parties entered into the following contract. Although, no representative of Sewer District No. 3, was present, C. B. Hosford, interested party of same, was contacted by phone and was in agreement with the Board in regard to the transaction.
