Also, Commissioners Order No. 290, embodying the above resolution was passed and ordered issued to the County Treasurer.

A. Olson from Olson from Olson Bros. conferred with the Commissioners and the County Director in regard to the purchase of a new boiler for the County Home. Mr. Olson said that he could get immediate delivery of two new boilers now in Kansas City, at the approximate cost of \$1000.00. The cost of installation was estimated in the amount of \$400.00. The Commissioners approved of the plan of having two boilers at the Home, and by unanimous agreement. order for same was placed with said Olson Bros.

Roslan Skinner, Sheriff, and Mr. Ransdell of the Ransdell Motor Company, appeared to discuss the purchase by the county of a new car for the Sheriff's department.

After some discussion, it was moved that the county purchase a Plymouth Sedan from the Ransdell Motor Company for the use of the Sheriff's department, at a price not to exceed \$1300.00, and that the County Clerk issue purchase order for same to the Ransdell Motor Company. Said motion was seconder and carried by unanimous vote.

All members of the Board of County Commissioners and the County Clerk met in the regular meeting rooms of said Board for the first meeting of the month.

Further bills against the county for materials and supplies were minutely inspected, then by proper motion ordered paid in amounts as recorded on the Allowance Record.

After approving the following resolution, the Board authorized the County Clerk to issue a beer license to Helen McDonald:

RESOLUTION

WHEREAS, on the 4th day of January, 1943, the same being a regular adjourned meeting of the Board of County Commissioners, the application of Helen McDonald for a beer license came on for consideration of said Board, and

WHEREAS, the Board does find that the said Helen McDonald is in all ways qualified under the law to sell cereal malt beverages for consumption on the premises, and

WHEREAS, the Board further finds that due and legal notice has been given to the Grant Township Board and that ten days have expired from the giving of said notice, and that no written objection has been filed by the Grant Township Board, protesting the granting of a beer license.

NOW, THERSFORE, BE IT RESOLVED, that the applicant Helen McDonald be granted a license to sell cereal malt beverages for consumption on premises at the place so described in application.

BE IT FURTHER RESOLVED that T. R. Gerhart, County Clerk of Douglas County, be, and he is hereby directed to issue said license.

As per appointment, Fred Gregory and members of the Kanwaka Township Board, namely, Frank W. Houk, Ralph Colman and Hubert Wulfkuhle and Township Treasure-elect Otto Johanning, met with the Board to determine if a verbal contract made between said/Board and the County Engineer E. E. Larson was still good. Said contract was made for the rocking of a certain road adjacent to property owned by Mr. Gregory. Mr. Larson had agreed that they could purchase rock from the county at 55% per yard delivered. Alva T. Hodges, County Foreman, said that this price was far below cost and that at the present time the county was unable to secure sufficient rock for its own use on county roads. Gregory said that he had planned to contribute \$90.00 toward the cost of rocking this road as per this

After considerable discussion, the county agreed to enter on the property of Fred Gregory for the purpose of ripping the rock and hauling same to the road, the Kanwaka Township Board to pay' the county the total sum of \$100.00. The Township Board agreed to crush said rock. Since all were in agreement, the following was signed:

AGREEMENT

THIS AGREEMENT made this 4th day of January, 1943, by and between the Board of Kanwaka Township and the Board of County Commissioners of Douglas County, Kansas,

WHEREBY, it is agreed that for the sum of \$100.00 said County Board will haul and distribute Three Hundred (300) yards of rubble rock, to be ripped out by Kamwaka Township on Mr. Fred Gregory's farm in said township, out on the road leading from said Mr. Gregory's house East onehalf mile. 'Said rock to be piled three (3) yards in a pile over the length of the road.

This work will be done as soon as conditions permit.
