April 21, 1943.

All members of the Board of County Commissioners and the County Clerk met in regular adjourned session this 21st day of April, 1943.

Salaries of C. E. Redmond, Acting County Engineer and Roy Hegeman, General Foreman, were increased as per the following motion: M. N. Penny moved that the salary of C. E. Redmond be increased to \$170.00 per month; and that the salary of Roy Hegeman, General Foreman, be increased to \$160.00 per month, both to become effective May 1, 1943. Ed Johnson seconded the motion. On vote, said motion carried by unanimous vote.

Bonds of the county officials, with the exception of the County Clerk's and the Coroner's, were approved as of this day. Also, included were the abstractors bonds of John Emick and Frank Banks.

An agreement between the City and County was entered into regarding the expense of rental etc. for the Rationing Board. Pursuant thereto, the following agreement was signed this day by the Chairman of the Board with the consent of the remaining two members.

MEMORANDUM AGREEMENT

AGREEMENT entered into this 9th day of April, 1943, by and between the City of Lawrence, Kansas, hereinafter called the City, and the Board of County Commissioners of Douglas County, Kansas, hereinafter called the County:

WITNESSETH: That whereas it has become necessary to acquire additional space for offices of the Douglas County War Rationing Board and its employees and it is proposed to use the south part of the basement of the Lawrence Community Building, comprising approximately 4000 square feet for said purposes, and it is necessary that the cost of providing such office space and the temporary partitions, counters and handrails, together with the cost of heat, light and janitor service and other expenses incident to the use and occupancy of said offices shall be apportioned equitably between the City and the County.

NOW THEREFORE in consideration of the premises and mutual covenants and agreements herein contained, it is agreed:

1. That the sum of \$60.00 per month is a fair and reasonable rental for such office space, such rental to include heat, water, light and janitor service necessary to properly conduct said offices.
2. That the expenditure of certain sums of money for labor and material for temporary partitions, handrails and counters is and will be necessary in order to provide suitable office quarters; such expenses to be born equitably between the City and County and on the same basis as the rental therefor.
3. It is further understood that currently from time to time there has been in the past and may be in the future certain items of expense such as stationery and emergency supplies which are not furnished by the National Government, but necessary to the proper and efficient operation of said office, which must be purchased and paid for by the City and the County.

It is therefore mutually agreed between the City and the County that the City as its portion of the above mentioned expense shall pay sixty percent of the total cost and that said County shall pay as its portion forty percent of such cost, and such expense shall be paid monthly by the City and County in said proportions until the 1st day of July 1943, after which the proportion of expense shall be paid by the City and the County on the basis of population of said City to that of the remainder of the County as determined by the records of the office of the County Clerk, and thereafter the respective portions of such expense shall be paid on the basis of population for such time as said Rationing Board may continue to occupy the above mentioned space.

IN WITNESS WHEREOF the parties hereto have executed this Memorandum Agreement this 30th day of April, 1943, in duplicate by their respective duly authorized officials.
