Torneden, Kampschroeder and Tuckel, appeared before the Commissioners for the purpose of discussing a drainage matter in Clinton Township and effecting certain landowners, among them, the three present at this meeting. In order to carrying off water drainking down hill and flooding certain parts of farms of the interested parties, the matter of digging ditches on both sides of the road was suggested and discussed. For work on the road, the Clinton Township asked to hiro equipment from the county: i. o., the Caterpillar tractor for the purpose of pulling the grader. The county, also, would have to furnish a man along with the tractor. The Board wished to discuss this with the General Foreman of the Roads and Bridges before giving an answer on this, and, also, thought it wise to look this situation over. Inspection of same was made this p. m., and after ∞ doing, the Commissioners returned to their regular meeting rooms.
