The following agreement was signed by the Board and Hubert Moodie :

AGREEMENT

THIS AGREEMENT made this llth day of August, 1943, by and between Hubert Moodie of Lawrence, Douglas County, Kansas, party of the first part, and the Board of County Commissioners of Douglas County, Kansas, party of the second part:

WITNESSETH that the said party of the first part in consideration of the sum of \$1.00, the receipt of which is hereby acknowledged, and the agreements of the party of the second part hereinafter stated, agrees that the party of the second part shall have the exclusive right and privilege for five (5) years from the date hereof to purchase all limestone gravel that it may desire which is located on the real estate owned by the said party of the first part, being described as follows, to-wit:

IN CONSIDERATION of which the said party of the second part agrees to pay the said party of the first part the sum of four cents $(4 \not$) for each and every cubic yard purchased by the said party of the second part.

THE SAID PARTY of the second part further agrees to provide all necessary equipment and labor to remove the gravel and to haul it away.

THE PARTY of the first part agrees to allow the party of the second part a convenient right-ofway from the gravel deposits to a public highway, the party of the second part to provide equipment and labor in constructing the road from the gravel pit to a public highway.

THE PARTY of the first part agrees that none of the gravel on the above mentioned real estate will be sold to any other person, firm, or corporation during the time this contract is in effect without the consent of the party of the second part.

THE PARTY of the second part to have the option of renewing the agreement at the expiration of the time of this agreement, if it so desires.

IN WITNESS WHEREOF the parties to this agreement have hereunto set their hands the day and year first above written.
