COMMISSIONER'S RECORD N

August 25, 1943.

In regular adjourned session this 25th day of August, 1943, all members of the Board of County Commissioners and the County Clerk met in the regular meeting rooms of said Board.

There appeared Robert Kampschroeder residing in Kanwaka Township, with the request that the County Board allow his property to be transferred from School District #35 to District #84. Mr. Kampschroeder has one child who will attend this school this year. He says the route to School No. 35 is longer and the road to same is in bad condition. He said he would have to take time off from his work to take the child; while the route to No. 84 is shorter and there is a good road. The child could go alone to this school and Mr. Kampschroeder would lose no time from his work. After listening to the plea of said Mr. K., the Board felt that his property should be transferred to another school district. Mrs. Margaret Hurley, County Superintendent, said that the Board of School District #35 had circulated a petition in an effort to keep Mr. K. in that district; however, since the County Board has authority in this matter to make such a transfer, the following resolution was passed;

"We, the County Commissioners of Douglas County, hereby resolve that the NE¹/₄ of the SM¹/₄ of Section 8, Township 13, Range 18, be detached from School District #35 and attached to School District #84, and authorize the County Superintendent to make this change in boundary, on August 25, 1943.

Several matters of business were discussed with the Acting County Engineer and the General Foreman of Road and Bridge Crew.

The County Clerk discussed the expenses of the Rationing offices and the share of same which must be born by the County and the City. As per the new population figures, the City will pay on the basis of 56.717% and the County on 43.283%. In accordance with the written agreement on file, this new percentage basis takes effect as of July 1, 1943.

The Board of Commissioners entered into a five-year contract with the Diebold Safe and Lock Company, Canton, Ohio, for the servicing and inspection of the safes in the office of the County Treasurer, for the sum of \$17.00 per year. Same will expire on November 23, 1948. (Contract is on file in the office of the County Clerk.)

The quarterly reports of the county officials for the quarter ending June 30, 1943, were accepted and approved by the Board.

Allen French, Auditor, since having completed the audit for the county offices of the records for 1942, made a verbal report to the Board. Mr. French made several suggestions and recommendations for the better collection of delinquent personal property taxes by the Sheriff's office. Also, he recommended that the Clerk of Court clear up his records by issuing unpaid warrants, and bringing his books up to date. As a whole, Mr. French said the records of the county were in excellent shape, and that the business of the county has been handled very economically.

No further business appearing, the Board adjourned.
