

## COMMISSIONER'S RECORD N

Douglas County Republican, Lawrence

Resolved, that a ration bank account, or accounts, as defined in General Ration Order No. 3, be opened and maintained in the name of this Corporation with the First National Bank of Lawrence, Kansas, or one of its branches, which bank shall act as an agency of and under the direction and supervision of the Office of Price Administration and shall be responsible only to the Office of Price Administration; that C. E. Redmond, Acting County Engineer and Roy Hegeman, County Foreman, are authorized on behalf of this corporation, and in its name: To sign ration checks, as defined in said Order; to indorse ration checks, or other ration evidences, owned, or held by this Corporation, for deposit in said account; and

Further resolved, that the First National Bank be and it hereby is authorized to receive and honor all ration checks signed in accordance with the foregoing resolution; and

Further resolved, that the foregoing resolution shall remain in full force and effect until written notice of their amendment or rescission shall have been received by said Bank, and

Further resolved that the foregoing authorization and resolutions shall apply to any and all ration bank accounts which this Corporation now is or may at any future time be required or authorized by the Office of Price Administration to open or maintain, without further authorization from the Board of County Commissioners of Douglas County, Kansas; and

Further resolved, that the County Clerk of Douglas County, Kansas, be, and he is hereby authorized and directed to certify to said First National Bank of Lawrence, Kansas, and to the Office of Price Administration the foregoing resolution and that the provisions thereof are in conformity with the laws of the State of Kansas.

The Board of County Commissioners, with all members and the County Clerk present, met in regular adjourned session this 20th day of October, 1943.

The Commissioners agreed as to the salary to be paid S. L. Mowder, employee of the Road and Bridge Department, as per the following motion:

Ed Johnson moved that S. L. Mowder receive the compensation of \$115.00 per month plus the use of the house recently constructed at Vinland, same to be effective on the date when said Mowder assumes occupancy of the house. M. N. Penny seconded the motion. On vote, all Commissioners voted "Aye".

The following resolution designating the depositories for the county funds as handled by the County Treasurer's office, was passed:

RESOLUTION DESIGNATING BANK DEPOSITORIES  
FOR PUBLIC FUNDS

WHEREAS, the bond of A. M. Gardner, Treasurer of Douglas County, is now being accepted and approved, and

WHEREAS, as provided in Section 9-305 of the 1941 Supplement to the General Statutes of Kansas, 1935, the Board of County Commissioners is given authority to designate bank depositories for public funds providing said banks give a good and sufficient bond, and

WHEREAS, it is provided that in lieu of the giving of such bond, said depository banks may deposit with the governing body, security as set out in the law, to the amount of seventy percent (70%) of the amount which may be on deposit therein by the county at any one time, and

WHEREAS, it is further provided that during the periods of peak deposits occurring at tax paying time and tax distributing time and continuing for a period of not to exceed sixty continuous days at any given time, and not to exceed one hundred and twenty days in any calendar year, the amount of all depository bonds given to secure public deposits shall be reduced in amount by one-half thereof; that is, during such sixty-day period the personal surety bond need only equal in amount the total deposits at any such time and the corporate surety bond need be only fifty per cent (50%) in amount of the total deposits at any such time; and that other security as set out by law, need be only fifty per cent (50%) in amount of the total deposits at any such time, and

WHEREAS, the Statutes provides that no bonds for security be required when such deposit is covered by insurance under provisions of the federal deposit insurance fund of the federal deposit
