In regular adjourned session this 27th day of October, 1943, there convened in the regular meeting rooms of the Board of County Commissioners, all members of said Eoard; there being present, also, T. R. Gerhart, County Clerk.

R. Skinner, Sheriff, requested that the Board give consideration to salary increases for the deputies in his office. The Board said that it would take this matter under consideration and check the budget in regard to the funds for the balance of this year before reaching a decision.

The report of court stenographer's fees was submitted by John Callahan, Clerk of Court, and signed by the Chairman of the Board.

The Board discussed the transfer of Ed Sanders, assistant to the Lone Star Park Superintendent, from the Lake to the County Shops. Inamuch, as it was thought that there was more need of his services at the Shops than the Lake, the following motion was made: E. N. Penny moved that Ed Sanders be transferred from his position at the Lone Star Lake to a position with the road crew, and that if he accepts such position, to report to Roy Regeman, General Foreman of the Road and Bridge Crews, on the first of November, 1943. Ed Johnson seconded the motion. On voto, motion carried unanimously.

Again, the matter of salary increases for the deputies in the Sheriff's Department came up for consideration, the Sheriff being present at such discussion.

After checking the budget carefully in order to determine if such increases could be made at this time, the Board discovered sufficient funds in said budget to cover the increases as set out in the following motion: M. N. Penny moved that the salaries of the three deputies in the Sheriff's office, namely. Elmer Schiller, Ed Harris and R. W. Sanders, be increased from \$130.00 to \$150.00 per month; and that the salary of Cecil Georgie, Jailer, be increased from \$70.00 to \$85.00 per month all to be effective the first of November, 1943

There was some discussion on precting traffic signs at certain points in Clinton Town due to the traffic hazard there. This matter was referred to the County Attorney. After which, the Board passed the resolution attached hereto, setting up the speed limit through the town of Clinton.
