Also CANCEL 1943 tax in the amount of \$2.17, based on a Real Estate valuation of \$100.00, charged to the Kansas Electric Power Company; Plate #W-1539, Page 224, Line 5, Wakarusa 1943 Tax Roll; Lot No. 121, Fairfax, School District No. 60.

ALSO CANCEL Sale No. 169 for 1942 tax in the amount of \$2.48 with 11% penalty and 15% advertising--Total Sale \$2.74 on Lot 121, Fairfax, School District No. 60.

Duplicate assessment. Assessed also by State on the Corporation Tax Roll."

Guy Weimer and Geo. Sullivan interested parties for the location of a certain road in Marion Township, for which Guy Weimer had petitioned for and which was viewed, appeared to see if the Board had reached a decision on same. Mr. Sullivan said that he would use this road occasionally and that he would give an easement across his land, in the event, that if at some future date, the road would ever be extended the full length as described in the petition.

At the present time, the petitioner is asking for only a portion of this road to be opened. The Board took no action on the petition this day.

The Board discussed the matter of a salary increase for Harold Wilburn, Janitor referring to the action as taken in April (Page 254 of the Minute Record) whereby said Wilburn's salary was increased to \$110.00 until the first of September, with the thought in mind that a further raise would be forthcoming. After some consideration, it was moved by Ed Johnson that the salary of Harold Wilburn be increased from \$110.00 to \$120.00 per month, effective the first of December, 1943. A second was made by M. N. Penny. On vote, called by Chairman Griffith, the motion carried.

Bids for the plastering and repairing of certain rooms in the courthouse, were submitted to the Board by the County Clerk and opened. The bidders and total amount as per specifications are as follows:

No acceptance of any bid was made this day, and the bids were tabled for further action.
