No. 321: CANCEL Dog tax in the amount of \$1.00, charged to James Belshe, 1400 N. J. Street, Lawrence, Kansas. Page 350, Line 1, 1943 City of Lawrence Tax Roll.

Clerical error

CANCEL personal property tax in the amount of \$7.50, based on an Intangible valuation \$1500.00, charged to C. C. Perkins, 1510 Mass. Street, Lawrence, Kansas. 1943 City of Lawrence Tax Roll, Page 418, Line 28.

Erroneous assessment.

CANCEL tax in the amount of \$1.21 on 2420 bushels of grain charged to Josephine Gilmore for the Gilmore Estate. Eudora Township 1943 Tax Roll, Page 33, Line 33. School District 71-2.

Deputy Assessor Chas. Starkweather failed to allow constitutional exemption.

CANCEL personal property tax in the amount of \$9.13, based on a Tangible valuation of \$295.00, and cancel tax in the amount of 25¢, based on an Intangible valuation of \$50.00 (Total tax \$9.38), charged to Mrs. C. E. Bredow, Jr., Lawrence, Kansas. City of Lawrence Tax Roll for 1943, Page 353, Line 3.

Erroneous assessment.

CANCEL personal property tax in the amount of \$15.00, based on an Intangible valuation of \$3000.00, charged to Lillian C. Phillips, 733 Kentucky St., Lawrence, Ks. City of Lawrence 1943 Tax Roll, Page 419, Line 26.

Erroneous assessment.

No. 318: CANCEL personal property tax in the amount of \$3.71, based on a Tangible valuation of \$120.00, charged to Wm. J. Seinald (Seiwald) 909 Conn. Street, Lawrence, Kansas. City of Lawrence 1943 Tax Roll, Page 431, Line 16.

Deputy Assessor failed to allow the constitutional exemption.

No. 319: CANCEL personal property tax in the amount of \$6.00, charged for the assessment of six (6) male dogs, in the name of A. E. Strobe, 868 Elm Street, Lawrence, Kansas. City of North Lawrence 1943 Tax Roll, Page 100, Line 33.

Deputy Assessor A. B. Conner erroneously assessed seven dogs when it should have been one.

No. 320: CANCEL personal property tax in the amount of \$7.50, based on an Intangible valuation of \$1500.00, charged to Floyd J. Wilson, 2205 Tenn. Street, Lawrence, Kansas. City of Lawrence 1943 Tax Roll, Page 450, Line 20.

Intangible property is in the State of Missouri, and was there on the first of March, 1943.

Due to the overpayment of taxes on a certain piece of property in Lawrence, the following Refunding Warrant was issued to J. L. Constant:

No. 89: Pay to J. L. Constant, the amount of \$97.24 on account of overpayment of 1942 tax on Receipt No. 2679, paid December 28, 1942 for the S 150' of N 200' Reserve in Lanes First Addition. Part of tax cancelled by State Tax Commission. Charge Refunding Warrants: Tax \$98.22 less discount of 98¢ = \$97.24.

Ebon Anderson, County Weed Supervisor, presented his annual bindweed report to the Board for approval and for signatures. After some inspection, by proper motion, the Chairman of the Board was authorized to sign same.

It was also moved, seconded and voted, that the Acting County Engineer be directed to remove the structure in Eudora Township known as the Moody Bridge.
