It was moved by M. N. Penny that the road petition of G. B. Weimer et al. be denied, and that the said Mr. Weimer be given sufficient material, laid on the ground, with which to construct the necessary bridge on his road described above, the bridge to be built at Mr. Weimer's own expense. The Township has agreed to do whatever grading is necessary on the road. Commissioner Griffith relinquishing the Chair to Commissioner Johnson, seconded the motion. On roll call by Acting Chairman Johnson, all Commissioners voted "Aye".

No further business appearing, the Board adjourned to meet Wednesday, December 29.

The Douglas County Board of Commissioners, with all members and the County Clerk present, convened in regular adjourned session this day.

A resolution, authorizing the issuance of beer license to the following applicant, was passed:

RESOLUTION

WHEREAS, on the 29th day of December, 1943, the same being a regular adjourned meeting of the Board of County Commissioners, the application of Melvin M. Molder for a beer license came on for consideration of said Board, and

WHEREAS, the Board does find that the said Melvin M. Molder, is in all ways qualified under the law to sell cereal malt beverages for consumption on the premises, and

WHEREAS, the Board further finds that due and legal notice has been given to the Wakarusa Township Board and that ten days have expired from the giving of said notice, and that no written objection has been filed by the Wakarusa Township Board, protesting the granting of a beer license.

NOW, THEREFORE, BE IT RESOLVED that the applicant Melvin M. Molder be granted a license to sell cereal malt beverages for consumption on premises at the place so described in application.

BE IT FURTHER RESOLVED that T. R. Gerhart, County Clerk of Douglas County, be, and he is hereby directed to issue said license.

It was moved by Ed Johnson and seconded by M. N. Penny that the following Refunding Warrant be issued. Motion carried by affirmative vote:

No. 90: Pay to Riley Rogers, the sum of \$2.20 for overpayment of 1942 tax on Receipt #3485, paid December 16, 1942. Wrong tax extended on receipt for Lots 50, 51 and 52 Walnut Park. Charge Refunding Warrants: Tax \$2.22 less discount .02 = \$2.20.

The Board authorized the Sheriff to purchase necessary supplies for the county jail. The Sheriff reported that he is in need of more blankets; and, also, a few minor repair jobs will be necessary for the interior of the jail. Other than this, he did not anticipate any other needs for the remainder of this year.

There are sufficient funds in the Bindweed Fund to purchase a truck for that department; however, preliminary steps will have to be taken and the proper authority contacted to determine if the county may purchase a truck at this time. The Acting Engineer was directed to secure the necessary information regarding the purchase of the truck. He was also authorized to secure bids on a truck for this department.
