After considerable discussion, the Board was of the opinion that such claim of Mr. Mitchell is made in good faith and that he did, at one time, pay to the county, through the tax collector's office, the personal property taxes for the years 1933 to and including 1938. Therefore, pursuant thereto, the following resolution was adopted by motion of M. N. Penny, seconded by Ed Johnson and unanimous vote:

RESOLUTION

WHEREAS, the matter of an offer to compromise personal property tax judgments against A. B. Mitchell, came on for consideration by the Board of County Commissioners of Douglas County, Kansas, at a regular adjourned meeting this 3rd day of May, 1944, maid liens appearing in Judgment Docket 8, Fage 178 in the office of the clerk of the district court of Douglas County, Kansas, and being more particularly described as follows:

Warrant No. 1869, for the year 1933, in the sum of \$40.26, plus fees and interest, filed April 5, 1937.

Warrant No. 3451, for the year 1934, in the sum of \$26.66 plus fees and interest, filed April 5, 1937.

Warrant No. 4832, for the year 1935, in the sum of \$45.57 plus fees and interest, filed April 5, 1937.

Warrant No. 6154, for the year 1936, in the sum of \$31.86 plus fees and interest, filed October 12, 1938.

Warrant No. 7385, for the year 1937, in the sum of \$22.90 plus fees and interest, filed January 16, 1940.

Warrant No. 8633, for the year 1938, in the sum of \$9.90 plus fees and interest, filed Earch 29, 1941.

THEREUPON, after hearing evidence presented by the said A. B. Mitchell, and being full convinced that these delinquent taxes had been paid to the Tax Collector of Douglas County, and error was made in that no credit was allowed on the books for same, the Board finds it only fair and just to cancel the tax lien judgments including all penalties and interest.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Douglas County, Kansas, that the Clerk of the District Court, be ordered to cancel the tax judgments described above, in the total amount of \$177.15, plus all interest and penalties now on his docket against A. B. Mitchell, sworm affidavit of said Mr. Mitchell being attached hereto.
