After considerable discussion, the board compromised the personal property taxes against Harold W. Emick, and passed the following resolution:

## RESOLUTION

WhileREAS, the matter of an offer to compromise personal property tax judgments against Harold W. Emick, came on for consideration by the Board of County Commissioners of Douglas County, Kansas, at a regular meeting this 1st day of June, 1944, said lions appearing in Judgment Docket B, page 86, in the office of the Clerk of the District Court of Douglas County, Kansas, and being more particularly described as follows:

Warrant No. 3165, for the year 1934, in the sum of \$11.60 plus fees and interest, filed April 5, 1937.

Warrant No. 4559, for the year 1935, in the sum of \$17.01 plus fees and interest, filed April 5, 1937.

Warrant No. 5859, for the year 1936, in the sum of \$16.36 plus fees and interest, filed March 29, 1941.

Warrant No. 7136, for the year 1937, in the sum of \$22.83 plus fees and interest, filed March 29, 1941.

Warrant No. 8374, for the year 1953, in the sum of \$38.11 plus fees and interest, filed March 29, 1941.

Warrant No. 9198, for the year 1933, in the sum of \$29.22 plus fees and interest, filed October 20, 1942.

Warrant No. 11836, for the year 1941, in the sum of \$37.79, plus fees and interest, filed May 22, 1944.

Said Board after fullconsideration of the matter, finds that it would be to the best interest of Douglas County to compromise said tax for the sum of \$172.92, which represents the payment of the not tax exclusive of penalties and interest.

NOW THEREFORE, BL IT RESOLVED by the Board of County Commissioners of Douglas County, Kansas, that the Clerk of the District Court, be ordered to cancel all interest and penalties on the tax judgments listed above and to accept the sum of  $\zeta 172.92$  for full settlement of same, the interest and penalties being hereby waived.
