June 21, 1944

All members of the Board of County Commissioners met in regular adjourned session.

The Board with E.A.Sims, Representative of the State Livestock Commission, appraised a T.B.Cow belonging to Leo Baker.

Lisle Eby discussed purchase of parsonage for First Christian Church and the application for tax exemption. Proper papers have been completed by County Clerk, and will be sent to State Commission of Revenue and Taxation.

The road petition of Albert Brune, et al, accepted and viewing date set for 2 o'clock P.M. at place of beginning on Wednesday, July 12th.

Motion for acceptance made by Penny, seconded by Johnson and unanimous vote.

Beginning at a point approximately 2300 feet west of the Southeast corner of Section 10, Township 12 South, Range 19 East, thence Northerly along the East line of Lake View property, and through School grounds to Railroad, and across Railroad; thence Northerly along high ground on the East side of the old Lake Bed to a point in Old Road #489.

E.E.Larson appeared and discussed the Wakarusa Bridge and future construction.

Ebon Anderson, Birdweed Supervisor, asked the Board to set a price for loading and hauling of salt to be used for birdweed purposes. The Board set 15¢ per ton for loading and 10¢ per ton per mile rolling. The Commissioners agreed that the City should apply its own chlorate on birdweed within the boundaries of the City.

S. J. Hunter appeared and reported the bonding company found no fault with report on business of the late County Treasurer Gardner, and will approve transfer on bond to Roy Flory as formerly discussed.

The Board adjourned to meet Wednesday, June 28th.
