Glenn Charlton of Charlton's Insurance appeared before the board in regard to the safe and hold up insurance for the Treasurer's office. At present only \$5000.00 is carried on contents of hold up insurance for the Treasurer's office. At present only \$0000.00 is carried on contents of safe in hold up insurance. Mr. Charlton suggested a new all risk policy which is written only for municipalities, county governments and banks. The new policy would cover every office in the Court House, persons acting as messenger for the county while enroute to and from the bank, the court house and the jail premises. A check register would have to be kept in the Treasurer's office, so that in case of a hold up, checks may be stopped. The new policy, written in the amount of \$10,000.00 for a three year period, would cost \$427.63.

Mr. Johnson made the motion that Mr. Charlton write the all risk policy in the amount of \$10,000.00 for the 3 year period, at \$427.63, with the refund for eleven months unused portion on the present policy premium credited back on the new premium. Mr. Penny seconded the motion, and on vote called, by Mr. Griffith, the motion carried.

The Board adjourned to meet as a special board on Tuesday, November 14th, to canvass the In-State, Out-of-County absentee ballots.

The Board of County Commissioners met in special session, all members of the board being present.

In accordance with the statutes, the board proceeded to canvass the In-State, Out-of-County absentee ballots.

L. Palmer. Second assessment was made by the deputy assessor in Wakarusa Township and signed by Deputy Assessor. Tax-payer's name is J. L. Falmer (or J. Leroy Palmer) and is known also as Roy Palmer.
