Sheriff Skinner was authorized to purchase 2 sub-machine guns @ \$74.50 each. Sheriff Skinner was also granted Clerk Hire & \$30.00 a month, beginning January 1, 1945.

also granted of the appendix of the application of Baker University for exemption from taxation to the State Commission of Revenue and Taxation. A copy of the appeal listing the real estate involved, is on file in the office of the County Clerk.

E. E.Larson, County Engineer was authorized to purchase materials and hire labor, and to encumber the road and bridge fund of the 1945 budget up to \$15,000.00. The new machinery which has been ordered is to be purchased out of the special equipment fund.

Mr. Penny made the motion that Larson use the materials and labor authorized above, in repairing the Eudora Road. Mr. Johnson seconded the motion, and on vote called, the motion carried.

Bids for repairing and redecorative the rest of the court house, including the halls, base-ment offices and the third floor were presented and accepted. Money was set aside for the work as follows.

Mr. Penny recommended that all the offices on the second floor have new lights installed, and the KEP was asked to present figures for the next meeting on December 30th. It was agreed not to install new lights in the Court room.

Mr. Penny made the motion that purchase orders be issued for all of the work yet to be done in the court house, and for the new lighting to be installed, before the end of the month. Mr. Johnson seconded the motion, and on vote called, the motion carried.

Application for priorities on a scrubbing and polishing machine was discussed, and the application was signed by Mr. Griffith, as chairman of the board. The machine is to be purchased through Grane & Company, complete with one set of brushes, for \$241.60.

Mr.Gerhart presented the request of E. M.Cameron for an adjustment on his personal property tax for 1944, stating that Mr. Cameron was taxed as being in School District 60, while he is actually in school district 6. The Board approved the adjustment as set out in the following Order.
