question has never been raised, and that not a word has been said against taking the colored people at the home. Mr. Harris asked if a person white or colored actually needed hospitalization and care, and has no one to take dare of them, they are eligible for the county convalescent home. The board assured Mr. Harris that that was right, and that if the people are physically able to care for themselves, and to get around, but still in need, they will be placed in some home and the county will pay for their keep.

John J.Riling appeared before the board and asked for a letter or a resolution in regard to cases being filed in the County Court, instead of in the courts of the Justices of Peace. The Board sent a letter to Mr. Riling, requesting that all cases in which the County is interested in any way, be filed in the County Court.

The quarterly reports for the fourth quarter of the year 1944 were presented and approved.

E.E.Larson, County Engineer, appeared in connection with the falaries of the road crew, and asked for a \$5.00 raise for certainmembers of the road gang. The Board approved the increases, effective with the February salary, as follows:
