Penny that a charge be made of \$2.50 per annum for motor boats used on the lake, and dock space on the lake shore to be leased at the rate of \$10.00 per annum. L'r. Johnson seconded the motion, and on vote called the motion carried.

The Board of County Commissioners met in regular adjourned session, all members of the Board being present.

N.T.Veatch, Clifford Ransey and Hugh Eoyce, property owners at Lone Star Lake, appeared before the Board in regard to the proposed arrangement at the lake, and to remind the Board of Commissioners of the existence of the Lone Star Association and the advisory board of said association which is to act in conjunction with the Board of County Commissioners, this being the first time part of the commissioners have heard of such a board. Mr. Veatch told the board he deeded the County approximately 25 acres of land at the lake for which he said he received no consideration other than the use of the road on the north with the understanding the road would eventually be closed and another one opened in another location, the gentlemen's agreement that the boat concession would be moved from in front of his cabin, and also sufficient water supply for his cabin. Mr. Veatch asked about the proposed dock space that had been designated for rent @ \$10.00 a year. The Board told Mr. Veatch the docks are to be along the north side of the lake in the east arm and the dock rights had been asked for by several persons.

Mr. Veatch made it plain to the board he wanted the road on the north closed, and a new one opened just as soon as could be done conveniently by the county, so he would be protected against adverse possession. Mr. Larson suggested the proposed road be platted on the map and the present road removed from the map so that at a future date the road would be in evidence on the plat as it should be laid out. Mr. Ramsey asked that the road be changed before any permanent plans are made for of the lake Association, and ask them to set a date to meet with the Board of Commissioners, J.A. stated he is not insisting that it be done immediately. Mr.Griffith said the board would give if the county goes ahead with the plans for improving the lake as now set out. Mr.Veatch also asked that the road ditching which has been undermining the fence line be looked at and if the county is responsible for the repairs to see that the fence line is fixed.

Lloyd Caines and W. H. Andrews appeared before the board in regard to the proposed paving of Louisiana Street from 19th Street South to Zrd Street. Mr. Penny asked Mr. Gaines to wait until after the new city council took office, but Mr. Gaines insisted upon an answer today. Mr. Gaines told the board if the Louisiana Street project is turned down, he, himself had drawn a petition asking for the paving of Barker Avenue and would circulate the same for signatures. Mr. Penny again asked Mr. Gaines to wait until the new city council took office, on May 1st, but Mr. Gaines was so very insistent for action on the petition, Mr. Grif (ith called for a vote, Mr. Johnson and Mr. Griffith voting against the petition and Mr. Penny voting in favor of the petition.

Mrs. Irone Cuthbert and Cleveland Everett appeared before the Board in response to a letter to Mrs.Cuthbert in connection with a petition for a private roadway signed by Mr. Everett.
