The Lake View Association is to furnish the labor. Mr. Francis touthe Board there were two gravel beds in the lake, approximate ly 40 feet deep, to which the county is welcome if the county will remove the gravel.

Mrs. Laurel Ringler, Mrs. L.G.Carter and Mrs. Lloyd Gaines appeared before the board in regard to the Girl Scouts cabin at the Lone Star Lake, Mrs.Gaines asked for sand to make a beach at the lake for the girl scouts, and the Board told Mrs. Gaines the sand would be furnished by the county. The Board also granted permission for the space for a boat dock, the space to be donated to the Girl Scouts. The GirlScouts also asked for additional cabin space for their outing at the lake, which is to be from July 2-29, and maybe a week longer. Permission was granted to use the canteen for that léngth of time.

No further busines, the board adjourned until Wednesday, April 18th.

TheBoard of County Commissioners mot in regular adjourned session, all members of the board being present.

Mrs. Melvin Goff, appeared before the board in regard to complying with the noxious weed law. Mr. Anderson, county weed supervisor was also present. Mrs. Goff stated she had sowed a lot of lespedeza on her farm, planning to sell it, and now Mr.Anderson has informed her there is bindweed in spots on the 80 acres, and she cannot sell the lespedeza or any other crop from the farm until the bindweed is eradicated. Mr. Griffith explained the pointion of the law providing for action by the county if complaints are filed by neighboring farmers. Some of Mrs. Goff's freighbors have complained about the bindweed. Mr. Anderson said there were a few spots on the North half of the 80 that could be treated easily and Mrs. Goff could sell the lespedeza from that portion of the farm this fall, but the South half of the 80 acres was overrun with bindweed and would be hard to treat. After some discussion, Mrs. Goff agreed to have the North half of the 80 acres treated.

Fred W. Kahn, County Treasurer, appeared before the board, asking for salary increases again, stating he had asked for increases for both Mrs. Davis and Mrs.Eudaly in the amount of \$10.00 each and for Roy Flory, deputy county treasurer, a \$15.00 increase. The board reminded the County Treasurer the increases for Mrs.Davis and Mrs.Eudaly had been granted at the time he asked for them on April 2nd, and at that time the request for the Deputy's increase was turned down. After some discussion, the board again refused the request for the increase of \$15.00 for Roy Flory, Deputy County Treasurer.

Mr. Kahn mentioned transferring to the cashier system, stating \$125.00 would have to be paid to a cashier if and when one is obtained.

The printing of the 1945 tax receipts was discussed, and the estimate of the World Company was discussed, and the estimate of the World Company was presented. It was moved by Mr. Penny the estimate of the Journal World Company be accepted and the contract let for the printing of 30,000 tax receipts at 3627.50. Mr. Johnson seconded the motion, and on vote called, the motion carried.

No further business, the board adjourned, to meet Saturday, April 21st.

The Board of County Commissioners met in regular adjourned session, all members of the board being present.

T.R.Gerhart, County Clerk, was authorized to employ krs. Gladys Johns as temporary help through the assessment period, at \$100.00 a month.

A letter enclosing \$2.00 was presented to the board concerning taxes assessed against Pfc. Harold K.Shroff. Upon investigation it was found there was a judgment on record in the office of the Clerk of the District Court in the sum of \$4.13 plus fees and interest, for personal property taxes for the year 1941, filed under Warrant No. 12253. It appearing to the board Harold K. Shroff was in the army of the United States at the time the tax becare due and delinquent and has been in the army since that time and is still in the army, the board should accept the \$2.00 which he enclosed in his letter and compromise. Thereupon the following resolution was adopted:
