## <u>RESOLUTION</u>

WEEREAS, the matter of an offer to compromise personal property tax judgment against Harold K.Shroff, came on for consideration by the Board of County Commissioners of Douglas County Kansas, at a regular adjourned meeting, this 21st day of April, 1945, said lien appearing in Judgment Docket 8, page 253, in the office of the Clerk of the District Court of Douglas County, Kansas, and being more particularly described as follows:

Warrant No. 12253, for the year 1941, in the sum of \$4.13, plus fees and interest, filed March 18, 1943.

Thereupon, after full consideration of the matter, and after hearing evidence presented in behalf of Harold K.Shroff, the Board finds that it would be to the best interest of Douglas County to compromise said tax for the sum of \$2.00, which represents the amount of money sent by said Harold K.Shroff who is a member of the armed forces.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Douglas County, Kansas, that the Clerk of the District Court be ordered to cancel all interest and penalties on the tax judgment listed above and to accept the sum of \$2.00 for full settlement of same, the remainder of the judgment, the interest and penalties being hereby waived.
