The question of paving Louisiann Street was again discussed, and the resolution issued by the City Council of the City of Lawrence, was again read and perused carefully. Mr. Johnson, acting as chairman of the board called for the motion, which was stated by Mr. Penny, as follows: To do away with the previous action of the Board of County Commissioners, and to proceed with the City of Lawrence in the paving of Louisiana Street from 19th Street South to 23rd Street, as set aut in the resolution of the City of Lawrence. Mr. Griffith, seconded the motion and on vote called, the motion carried. The County Attorney was instructed to prepare the proper resolution and submit it for signatures on Wednesday, June 27th.

The Board adjourned to act as road viewers on the petition signed by W. M. Leonhart and others for the vacation of Road No. 52, as set out in the petition, as heretofore designated in the notice of publication. Upon viewing the road, the following resolution ordering the vacation of the road was adopted:

RESOLUTION

We, the Board of County Commissioners of Douglas County, Kansas, acting as Viewers of a road petitioned for by W. E. Leonhart, and others, of Wakarusa Township, met as heretofore determined, and ordered by the board, at the beginning point of the road as petitioned for to be vacated, on the 25th day of Fay, 1945, and proceeded to view the route of the road as prayed for in the petition for vacation, and

WHEREAS, proper legal notice having been given as required by law, and no objections having been made to the vacation of the road, the petition of W. M. Leonhart, and others, for the vacation of a road being under consideration of the Board of County Commissioners for final action, it is determined and ordered by the Board that the public good and convenience does not require that said rand right of way remain on the records as a public road, and we hereby determine that said road should be vacated.

NOW THEREFORE, BE IT RESOLVED by the Board of County Commissioners that the road descrited in the petition of W. M.Leonhart, and others, as

> Road No. 52, extending North and South across the Southeast Quartor of Section 6, Township 13, Range 20, the center line of which road being approximately 994 feet East of the West line of mid Quarter Section,

be and the same is ordered vacated, and the Trustee of Wakarusa Township be directed to cause said road closed for public use.

RESOLUTION

RESOLUTION RELATING TO GRADING, CURBING AND PAVING LOUISIANA STREET AND A HICHWAY, BOTH EXTENDING FROM 19th STREET TO 23rd STREET IN THE CITY OF LAWRENCE, SAID HIGHWAY BORDER-ING ON THE LIMITS OF SAID CITY, FIXING AND DETERMINING THE BOUNDARIES OF THAT PART OF THE BENEFIT DISTRICT LYING WITHOUT THE COR-PORATE LIMITS OF SAID CITY AND PROVIDING FOR THE PAYMENT OF THE COST THEREOF.

The Whereas, the Board of County Commissioners of Douglas County, Kansas, have received a Resolution from the city officials of the City of Lawrence, Kansas, as provided in Section 12-648 of the Ceneral Statutes of Kansas, 1935, which Resolution relates to the grading, curbing and paving of Louisiana Street and a highway adjacent thereto and extending from the intersection of 19th Street and Louisiana Street to 23rd Street in the City of Lawrence, Douglas County, Kansas, which street and highway connects with existing paving in the City of Lawrence, and extends along the most
