The regular monthly claims for payroll and services were approved and allowed as per the Allowance Record.

Cancellation of the 1945 personal property tax assessed against Mrs. Ella Daniels was ordered as per the Cancellation Order No. 375 as follows:

Order No. 375: Cancel Personal Property Tax assessed as follows: City Tax Roll, School District #60. Statement No. 897
Mrs. Ella Daniels, 1100 1/2 Connecticut, Lawrence, Kansas.
Tangible Value \$50.00 Tangible Tax \$1.71
Constitutional exemption of \$200.00 was not allowed.

Roy Flory, County Treasurer was authorized to hire extra clerk hire during tax paying time, but the board emphasized Mr. Flory must not exceed his budget.

Ebon Anderson, bindweed supervisor asked for permission to purchase 2 ton of chlorate from Shawnee County, and the following equipment at the following prices:

It was moved by Mr. Penny, Mr. Anderson be authorized to make the above purchases. Mr. Johnson seconded the motion and on vote called, the motion carried.

The Lecompton Township Board was called in to discuss the condition of certain roads and ditches in Lecompton Township, upon complaint filed by Perry Smith. The Township agreed to take care of the road.

The following resolution was adopted by the board, declaring the improvement of Haskell Avenue from 13th Street to the South side of 14th Street, a public utility:

RESOLUTION

RESOLUTION RELATING TO GRADING, CURBING, PAVING AND OTHERWISE IMPROVING HASKELL AVENUE FROM THIRTEENTH STREET TO THE SOUTH SIDE OF FOURTEENTH STREET, SAID AVENUE BEING A BOUNDARY LINE STREET TO THE CITY OF LAWRENCE.

WHEREAS, The Board of County Commissioners of Douglas County, Kansas, have received Resolution No. 1848 from the city officials of the City of Lawrence, Kansas, as provided in Section 14-540 of the 1941 Supplement to the General Statutes of Kansas, which resolution relates to the grading, curbing, paving and otherwise improving of Haskell Avenue, from Thirteenth Street to the South side of Fourteenth Street, said Avenue being the boundary line street to the City of Lawrence.

WHEREAS, The Board of County Commissioners of Douglas County, Kansas, has considered said Resolution, and does hereby approve the same.

THEREFORE BE IT RESOLVED:

By the Board of County Commissioners of Douglas County, Kansas, that it is expedient and necessary and in the public interest, to grade, curb and pave Haskell Avenue, from Thirteenth Street to the South side of Fourteenth Street, said Avenue being a boundary line street to the City of Lawrence; that said proposed improvement is declared a public utility; and that the cost thereof be paid as provided for in Sections 14-541 and 14-542, of the General Statutes of the State of Kansas, 1935.

ADOPTED by the Board of County Commissioners of Douglas County, Kansas, on this 1st day of November, 1945.
