Cancellation Order No. 390,

Cancel the following 1945 personal property tax assessed in Eudora City, School Districts 28 and 2, as follows: Statement #8335. White Spot Cafe, Eudora, Kansas.

Tangible Value \$500.00 Tangible Tax \$17.98

Substitute in lieu of the above cancellation, the following tax:

White Spot Cafe, Eudora, Kansas.

Tangible Value \$125.00 Tangible Tax \$3.22

The difference of \$375.00 constitutes an erroneous assessment.

Cancel the special tax for cutting weeds as entered on the City of Lawrence Tax Roll for 1945, Page No. 5982, Chester E. Foster, 645 California Street, Lawrence, Kansas, Real Estate described as SW 1/4 Block 47 West Lawrence, in the Amount of \$10.00. A letter received from the City Clerk, certifies the \$10.00 weed tax as above cancelled was erroneously assessed.

The Board of County Commissioners and Engineer from Leavenworth County were present and the following action was taken:

"At a joint meeting of the Boards of County Commissioners of Leavenworth and Douglas Counties, in reference to the river project at Eudora, it was decided to order 150 units of steel jetty from the Rehfield Steel Jetty Company, of Manhattan, at a price of \$20.80 a piece, laid down in Eudora. The labor is to be furnished by the two counties in the installation. The Jetty Company is to furnish a punch. Each county agreed to share equally in the expense of the materials and installation, being a joint project between the two counties".
