The Board of County Commissioners of Douglas County, met in regular adjourned session, all members of the board being present.

Regular claims for payroll and services were approved and allowed as per the allowance record.

The County Engineer asked for authority to purchase a used blue print machine. After some discussion, the motion was made by Mr. Penny authorizing the County Engineer to purchase such a machine from the Kansas Electric Power Company. Mr. Johnson seconded the motion and on vote called, the motion carried.

The County Engineer also asked for fluorescent lights in the drafting room. Motion was made by Mr. Penny to authorize the County Clerk to purchase 10 units of fluorescent fixtures for the drafting room. Mr. Johnson seconded the motion and on vote called, the motion carried.

Frank E.Banks presented his abstracter's bond in the sum of \$7500.00 as required by law, said bond was approved. H. N. Hoskinson, Township Treasurer of Falmyra Township presented his new bond in the amount of \$10,000.00 for approval, said bond being an increase of \$4,000. over last year's bond, said bond was approved.

County Commissioners' Order No. 403 was approved and issued as follows:
