"RESOLUTION"

RESOLUTION RELATING TO AN ANNUAL LEVY FOR THE PURPOSE OF CREATING A SPECIAL FUND TO BE USED FOR THE PURPOSE OF ACQUIRING A SITE FOR, AND THE BUILDING, EQUIPPING AND FURNISHING OF A COURTHOUSE AND JAIL.

Whereas, The Board of County Commissioners of Douglas County, Kansas, deem it expedient and necessary to create a special fund, in the sum of three hundred and eightynine thousand, two hundred and thirty-two dollars (\$389,232.00), to be used for the purpose of acquiring a site, and the building, equipping and furnishing of a courthouse and jail.

> THEREFORE BE IT RESOLVED: By the Board of County Commissioners of Douglas County, Kansas:

> > SECTION I

That an annual tax levy of one (1) mill be levied upon all the taxable tangible property in Douglas County, Kansas, for a period of ten (10) years, beginning with the year 1946, and continuing to and including the year 1955.

SECTION II

That the total amount of money to be raised by said levy shall be three hundred and eighty-nine thousand, two hundred and thirty-two dollars (\$389,232.00) and no more.

SECTION III

That no levies will be made under this Resolution until the same shall be published for three successive issues in the official Douglas County paper, provided that no petition in opposition to the same as provided by law, is filed with the said Board of County Commissioners of Douglas County, Kansas within thirty (30) days following the last publication of this Resolution.
