N.B. The following County Commissioners order was approved and issued at the regular meeting on January 7, 1946, and should be incorporated as a part of the minutes of the meeting of the board held on that day.

No. 404. To cancel 1945 personal property tax as follows:

S. W. Lohman, 915 Ohio St., Lawrence, Kansas. State #2514.
Tangible Valuation \$215. Tangible Tax \$7.36. There will remain unpaid on this tax item a tangible tax of \$10.28 plus intangible tax of \$.50 plus dog tax of \$1.00 to total \$11.78. This cancellation is made as an erroneous assessment based on Mr. Lohman's letter of 12-13-45 stating that he lived in Lawrence only 7½ months of the assessment year.

Harold B. Pepinsky, 1231 Oread Ave., Lawrence, Kansas. State #3168.
Tangible Valuation \$55. Tangible Tax \$1.88. There will remain unpaid on this tax item a tangible tax of \$1.37 plus intangible tax of \$.50 to total \$1.87. This cancellation is made as an erroneous assessment based on Mr. Pepinsky's statement on his tax bill that he lived on Lawrence only a portion of the tax year.
