The Board of County Commissioners of Douglas County met in regular session, all members of the board being present.

The bindweed Supervisor, Ebon Anderson, was reappointed for 1946, with an increase of 50¢ a day, making his total pay \$5.00 a day beginning March 1st.

Raymond F.Rice as attorney for the Lawrence National Bank, Successor-Trustee under the Will of Albert Henley, deceased, W.A.Schaal, executive vice president and trust officer of the Lawrence National Bank, Karl Klooz representing the University of Kansas, and Shelly Grable representing the Attorney General's office, were all present in regard to the placing of the property known as the "Henley Home" described as S_2^{\perp} of Lot 3 and all of Lots 4 and 5 in Hlock 6 Lane's First Addition on the tax roll for escaped taxes since 1939. The property was removed from the tax roll in 1939, and in view of an admitistic state is a month in the lawrence Daily Home. and in view of an advertisement in a recent issue of the Lawrence Daily Journal-World the property was placed on the tax roll by county commissioners' order No. 412 issued on February 20th. After considerable discussion, the County Attorney advised the board of commissioners to rescind their previous order. Therefore, County Commissioners' Order No. 414 was issued as follows: "Upon instructions received from the Attorney General's office and the County

Attorney of Douglas County, cencel our previous order No. 412 dated February 20, 1946, which order returned the property known as the Henley Home described as S_2^1 of Lot 3 and all of Lots 4 and 5 Block 6 Lane's First Addition to the City of Lawrence, to the tax roll as escaped taxes.

The letter of opini in from the county Attorney being attached to the copy of the order on file in the office of the County Clerk.

John Brand, J. G. McElhinny, Roy Borgen, Robert Groom and various others from the K.U. Young Republican's Club appeared before the board to protest against the recent action of the board regarding beer and dancing, as passed on February 20. Considerable discussion was had, but no action was taken by the board.

No further business the board adjourned to meet Monday, March 4th.
