Mrs. Chas. Whedon and Mrs. Ernest Leary presented a petition signed by 100 members of the Fairview Community, requesting the board to name the recently built bridge in that neighBorhood "The Fairview Bridge" Upon proper motion, second and vote, the bridge recently constructed over the Wakarusa at the County Farm was named the "Fairview Bridge".

The Board accompanied by E.A.. Sims of the State Livestock Commission viewed the tubercular cow belonging to A. L. Powell, which cow was appraised by the board and Mr. Sims @ \$125.

The Board accompanied by County Engineer Larson viewed the road beginning at the SW corner of 14-14-20 and running North 1 mile to the NW corner of 14-14-20 and then straight north to a point 50 rods North of the Northwest corner of 14-14-20 and the bridge located along said road. The Board agreed to straighten the creek with the provision the township or property owners along the road will put up 75% of the cost before the work is done, the remaining 25% of the cost to be paid by the County.

Henry C. Brinkman whose term is up as a member of the School District Reorganization Committee, was reappointed by the board for a term of two years.

The road petition submitted by E.S. Parnell, asking for a location of a road beginning at the NW corner of SW2 of 2-12-19, thence South on Section line one half mile to NW corner of Lot 1 of Fractional NW2 of 11-12-19, was laid aside bending further consideration. Said petition was signed by 14 property owners along said proposed road.

Since two membors of the board will be out of town attending a meeting the first of May, the board will not meet until May 2nd.

No further business the board adjourned.

## May 6, 1946

The Board of County Commissioners of Douglas County not in regular session, all members of the board being present.

Additional bills for services and supplies were approved and allowed as per the allowance record.

A letter was written to the Mayor and City Council asking for the permission to connect Sewer District #4 with Sewer Manhole A-29 in the 2000 Block on Learnard Avenue. Sewer District #4 is to be established with the construction of the sewer on Learnard Avenue in compliance with the action of the board on April 17th.

Alfred Heck appeared before the board asking the board to cancel the resolution adopted on November 25, 1942, closing the grade crossing transversing the right of way of the Union Pacific Railroad near milepost 37.42 East of Lawrence and running North and South about midway between the East and West boundary lines of Section 21-13-20. The County Attorney was instructed to write a letter to John Robinson, local agent of the Union Pacific Railroad, notifying the railroad of the request.

The attention of the board was called to certain existing health hazards, and the board directed Dr. J. M. Mott to enforce Section 65-159 of the General Statutes of Kansas for 1935 which deals with such hazards and provides a penalty therefor.

Upon proper motion, second and vote, Ed Johnson was directed to look after the county farm, checking on the progress and work done twice a week.
