

Douglas County Republican, Lawrence

June 10, 1946

The City Council met in regular session with Mayor Russell presiding and Councilmen Allen, Haggart, Stevens, Ferguson, Selig, Russell, Eustace, Burgert, Berger, Graeber, Bushey and Pine present.

Minutes of the previous meeting were read and approved.

County Commissioners Penny and Johnson to comprise a City-County Joint Body to open bids on paving for Louisiana Street from 19th to 23rd Streets and Haskell Avenue from 13th to 14th Streets.

Bids as follows were opened:

Moved by Penny, second by Johnson that the contract for paving Louisiana Street from 19th to 23rd Streets and Haskell Avenue from 13th to 14th Streets be awarded to Constant Construction Company. Carried.

Moved by Allen, second by Graeber, that the contract for paving Louisiana Street from 19th to 23rd Streets and Haskell Avenue from 13th to 14th Streets be awarded to the Constant Construction Company. Carried. Ayes: Allen, Haggart, Stevens, Ferguson, Selig, Russell, Eustace, Burgert, Berger, Graeber, Bushey, Pine. So ordered.

Commissioners Penny and Johnson adjourned.

The Board of County Commissioners of Douglas County met in regular adjourned session, all members of the board being present.

Dr. J. M. Mott was present to discuss a tentative budget for 1946, and to discuss a 1/2 mill levy for the health department, which has now been authorized by law. No definite action was taken this day.

Frank B. Dodds presented an application for the removal of certain lots from the city limits described as follows:

All of Blocks Numbered 1, 2, 3, 4, 22, 23, 24, 25, 26, 27, 28, 29, 30, 31, 48, 49, 50, 51, 52, 53, 54, 55, 56, 57, 82, 83 and 84, and all the streets and alleys adjacent thereto and lying in said tract, streets being streets number 15, 16, 17, 18 and 19 running east and west, and streets named J, K, L. M. and N running north and south through said tract, according to the survey and was a part of the platted tract of the City of Eudora, Kansas,

Attached to said petition was a recommendation signed by the Mayor and City Clerk of Eudora City, duly acknowledged, requesting the petition of Mr. Dodds be granted according to law, and that the blocks, streets and alley adjacent thereto, as described in said petition be vacated and excluded from being a part of the City of Eudora. Also attached to said petition, is a proof of publication of notice of the hearing on said petition. No one appearing to represent the City of Eudora, it was moved by Mr. Johnson the hearing on the application be continued until 11 o'clock, June 19th, and the City officials be notified of the hearing and their presence requested. Mr. Penny seconded the motion and on vote called, the motion carried.

Mrs. Simmons, Clerk of the District Court was authorized to hire Mrs. Ehrlich to do extra typing before and after the office hours of the County Attorney.

The Board adjourned to meet with Alfred Heck, the County Engineer and a representative of the Union Pacific Railroad at the crossing east of Lawrence. It was proposed at this meeting to close the crossing which sets on an angle and to reopen the crossing which was closed in 1942, at right angles, which new crossing is to be located on the south half mile line of 21-12-20, east of Lawrence, on the main line of the U. P. RR.

The following agreement covering Sewer District No. 5 was executed:

AGREEMENT

THIS AGREEMENT, made and entered into this 12th day of June, 1946, by the Board of Commissioners of Douglas County, Kansas, and the Governing Body of the City of Lawrence, Kansas, witnesseth that

WHEREAS, under provision of Chapter 165 of the Session Laws of the State of Kansas for 1927, the Board of Commissioners of Douglas County, Kansas, are forming what is known as the Douglas County Sewer District No. 5, the same comprising a tract of land lying along both sides of Learned Avenue between 15th Street and 19th Street and along both sides of Forest Avenue, all being adjacent to the City of Lawrence, Kansas, and

WHEREAS, it is the desire of said Board of Commissioners of Douglas County, Kansas, to connect said Douglas County Sewer District No. 5, with the sewer system of the City of Lawrence, Kansas, at a point with Sewer manhole A-25 located approximately 500 feet North and 590 feet East of the intersection of 19th Street and Learned Avenue, and the Governing Body of the City of Lawrence, Kansas, is willing that such connection be made and that the sewerage from said Douglas County Sewer District No. 5, may flow through the mains of the sewer system of the City of Lawrence, Kansas, on certain terms and conditions.
