Henry Wiskimen was also present. Upon checking into the matter, it was found Mr. Erwin owned 4 houses addressed as follows: 2240 Barker, 2242 Barker which is under construction, 2244 Barker and 312 E. 23rd, and a garage and shop at 2246 Barker. The assessment sheet does not show an assessment for the house at 2240 Barker, which the assessor stated he did not realize belonged to Mr. Erwin. The house at 2242 Barker was assessed as a complete structure but Mr. Erwin stated the ground had not been broken for the building on March 1st, and that only a pile of lumber was there. After some discussion, and upon the recommendation of the assessor, who acknowledged his error, the following valuations were placed on the following properties, all listed on W-730.

- 2240 Barker, to be assessed at \$2100.
- 2242 Barker, under construction, lumber only to be assessed, \$400.
- 2244 Barker, to be assessed at \$1500.
- 2246 Barker, garage and shop, at \$800.
- 312 E. 23rd, to be assessed at \$4000.

making a total improvement assessment of \$8800.

Mrs. Mattie Cabbell (Barker) appeared in regard to the increase in valuation of the improvements at 629 Vermont. After considerable discussion, no changes were made in the valuation of the property, as placed thereon by the board of equalization.

No further business, the board adjourned to meet Friday, June 14th.
