

COMMISSIONER'S RECORD N

Douglas County Republican, Lawrence

The policy covering the buildings and equipment at the county farm, written by the Manley Insurance Agency, was increased as follows:

Item 15 amended to read "\$100. on two head of horses with limit of \$50.00 each."

Item 16 amended to read "\$960. on twelve head of cattle over two years old with a limit of \$80. each"

Item 19 to be added, covering a one story brick dwelling, composition roof, in the amount of \$3500.,

Frank B. Dodds was present for the continued hearing on his application for the removal of certain lots from the city limits of Eudora. No one being present from Eudora City in response to the following letter which was written to the Mayor, City Clerk and City Treasurer, the hearing continued:

We have an application filed by Frank B. Dodds, for the removal of certain lots from the Eudora City limits.

It was moved by Mr. Penny the application of Mr. Dodds be accepted and the lots as described therein be removed from the city limits of Eudora according to Section 12-504 to 510 inclusive, of the general statutes of 1935. Mr. Johnson seconded the motion and on vote called, the motion carried, and the following resolution was adopted:

RESOLUTION

WHEREAS, F.B. Dodds, a resident of the City of Lawrence, Douglas County, Kansas, has filed a petition and given notice as required by law in Sections 12-504 to 12-510 inclusive of the General Statutes of Kansas, 1935, to vacate and exclude from the corporate limits of the city of Eudora, Douglas County, Kansas; that a hearing on the above matter was set for June 12, 1946 at 11:00 A. M. o'clock, and the said Board of County Commissioners of Douglas County, Kansas, adjourned the hearing from June 12, 1946 at 11:00 A. M. o'clock to June 19, 1946 at 11:00 A. M. o'clock, and said Board of County Commissioners gave notice to the mayor and city officials of the city of Eudora, Douglas County, Kansas, in regard to the hearing on the 19th day of June, 1946 at 11:00 A. M. o'clock. The petitioner, F.B. Dodds, appearing in person before the Board of County Commissioners and no other persons appearing.

WHEREAS, the Board of County Commissioners of Douglas County heard the testimony and examined the notice in regard to notice of hearing of said matter which was given by publication, and finds that due and legal notice has been given as required by law, and

WHEREAS, The Board of County Commissioners of Douglas County, Kansas, further finds that the faceting of the following described real estate:

"Blocks One (1), Two (2), Three (3), Four (4), Twenty-two (22), Twenty-Three (23), Twenty-four (24), Twenty-five (25), Twenty-six (26), Twenty-seven (27), Twenty-eight (28), Twenty-nine (29), Thirty (30), Thirty-one (31), Forty-eight (48), Forty-nine (49), Fifty (50), Fifty-one (51), Fifty-two (52), Fifty-three (53), Fifty-four (54), Fifty-five (55), Fifty-six (56), Fifty-seven (57), Eighty-two (82), Eighty-three (83) and Eighty-four (84) and that part of the streets numbered Fifteenth, Sixteenth, Seventeenth, Eighteenth and Nineteenth, running East and West across and through said tract, and the streets named J, K, L, M, and N running North and South across and through said tract, and being adjacent to and a part of said land" will not injure or endanger the private rights of any individual or person, and the public will suffer no loss or inconvenience thereby, and in justice to the petitioner the prayer of the petitioner ought to be granted.

THEREFORE, it is resolved and ordered that the vacation of the real estate herein described be vacated and excluded from the corporate limits of the city of Eudora, Douglas County, Kansas, and that such lands shall be listed for future taxation the same as though it had never been a part of the city of Eudora, and that the costs of the proceedings in regard to this matter be paid by the petitioner, F.B. Dodds, as provided by law.

The resolution was carried by a unanimous vote, this 19th day of June, 1946.
