RESOLUTION

BE IT RESOLVED: That the Chairman of the Board of County Commissioners and the County Clerk be, and they are hereby authorized and directed to execute for and on behalf of the County of Douglas, contracts between the County and the State Highway Commission of Kansas, giving the State Highway Commission of Kansas authority to act for the County, and in its place and stead, to obtain for the County such benefits as are obtainable under the postwar program of the Federal Aid Plan of Highway Construction, and obtain the benefits of such legislation for the County on the terms and conditions set forth in such contracts as may be prepared and approved by the State Highway Commission for Project No. 23S216 (1).

RESOLUTION

WHEREAS, by agreement with the State Highway Commission and the Federal Works Agency, Public Roads Administration by Douglas County, Kansas, executed on the June 25, 1946 by the governing body of Douglas County, Kansas, said County agreed to furnish all right of way within said County necessary, and as shown by the plans, for the construction of Project No. 23-S 216 (1), and,

WHEREAS, The County, the State Highway Commission, and the Federal Works Agency, Public Roads Administration are anxious that construction may be commenced as quickly as possible.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of Douglas County, Kansas that the County Clerk of said Douglas County, Kansas be and hereby is authorized to certify to the State Highway Commission when the right of way necessary for Project No. 23-S 216 (1) is procured, and Douglas County Kansas hereby agrees to save the State Highway Commission and the said Federal Works Agency, Public Roads Administration forever harmless from any and all liability by action or suit brought against said parties for abuttal or right of way damage through construction of said project on present road right of way or as a result of construction commenced in reliance upon said certification of right of way procured by said county.
