## COMMISSIONER'S RECORD N

WHEREAS, it is now necessary for said Board of County Commissioners of Douglas County, Kansas, to secure funds to pay for its proportionate share in furnishing materials and other items for the improvement of said street, and

WHEREAS, it appears that the share of the cost of improving said street, to be paid by The Board of County Commissioners of Douglas County, Kansas, is the sum of \$3,385.67, to be paid as provided in Sections 14-541 and 14-542 of the General Statutes of Kansas, 1935.

NOW THEREFORE, BE IT RESOLVED that the Board of County Commissioners of Douglas County, Kansas, issue and sell temporary notes under the authority of the General Statutes of Kansas, 1935, Section 10-123, in the aggregate sum of \$3,385.67 for the purpose of obtaining money to pay its proportionate share for the improvement of said street.

That said temporary notes be numbered one to four consecutively, three of said notes to be in the denomination of \$1,000.00 each, and one in the amount of \$385.67; that said notes be payable to bearer; that said notes be dated the 10th day of July, 1946; that said notes be due two years after date thereof, but be payable sooner at the option of The Board of County Commissioners of Douglas County, Kansas, when funds from the sale of bonds to be issued to pay the cost of such improvements are available therefor; that said notes bear interest at the rate of two per cent per annum, payable semi-annually on the 10th day of July, and of January of each year after the date thereof, and that said notes shall be substantially in form as follows:

That The Board of County Commissioners of the County of Douglas, State of Kansas, a municipal corporation, for value received, does hereby acknowledge itself to be indebted to and promises to pay to the bearer hereof, the sum of \$\_\_\_\_\_\_\_ in lawful money of the United States of America, on the lOth day of July, 1948, or the due date of the first installment of bonds to be issued for the payment of the improvements hereinafter mentioned, as may be sooner in point of time, together with interest thereon at the rate of two per cent per annum, payable semi-annually on the lOth day of January, 1947, and the lOth day of July and January of each year after the date hereof, until the principal sum hereof shall be fully paid, both principal and interest of this note being payable at the office of the Treasurer of Douglas County, Kansas, in the City of Lawrence, Douglas County, Kansas, and The Board of County Commissioners of the County of Douglas, State of Kansas, is held and firmly bound by these presents, and the full faith, credit and resources of said Board of County Commissioners are hereby pledged for the prompt payment of said principal and interest at maturity.

This note is one of a series of notes in the total amount of \$3,385.67, issued for the purpose of evidencing indebtedness heretofore duly authorized by The Board of County Commissioners of the County of Douglas, State of Kansas, for the making of certain improvements, towit: the grading, curbing, paving and otherwise improving Haskell Avenue from Thirteenth Street to the South side of Fourteenth Street, said Avenue being a boundary line street to the City of Lawrence, Douglas County, Stats of Kansas. This is a project designated as Haskell Avenue paving project, which improvements are to be paid for in part by the issuance of bonds, under the authority of Section 14-541 and 14-542 of the General Statutes of Kansas, 1935, and this note as well as all other notes of this issue are issued under the authority of, and in conformity with, the provisions, restrictions and limitations of the Constitution and Laws of the State of Kansas, and specifically authorized by Section 10-123 of the General Statutes of Kansas, 1935, and this note, together with all interest to become due thereon, is to be paid by said The Board of County Commissioners of the County of Douglas, State of Kansas.

The Board of County Commissioners of the County of Douglas, State of Kansas, reserves the right to pay this note at any time prior to the maturity date hereof.
